III. SOLDIER'S MEDAL. — By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, and Transfer Order 30, 1948, the Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to the following named airman:

> AIRMAN SECOND CLASS TERANCE K. JENSEN, AF17276985, distinguished himself by heroism involving risk of life on 16 April 1955 at Mount Clemens, Michigan. On that date, while on duty as Town Patrol Air Policeman, AIRMAN JENSEN'S attention was attracted by cries for help from an individual in the Clinton River. AIRMAN JENSEN immediately ran to the bank of the river, stripped off his clothing, and without regard for his own safety, plunged into the icy water in an attempt to save the victim's life. The drowning individual was going down for the third time as he reached her, but due to her hysterical condition, she still attempted to fight off her rescuer. Despite the danger involved and the possibility of drowning himself, AIRMAN JENSEN rescued the girl from certain death. With unusual presence of mind, he administered first aid until the arrival of the ambulance. Through his exemplary courage and humanitarian! MASTER action, AIRMAN JENSEN has reflected great credit upon himself. and _, WEL RECORDS the United States Air Force.
