**Dear VSPA Members and Guests,**

Two different couples from the VSPA (Greg & Sheila Cain and Bill & Janice Cummings) have inspected the Desert Diamond Casino and Hotel in Tucson, Arizona. They have attended several of our reunions and are very familiar with our reunion requirements, including those for the Sisterhood, the BX and the Hospitality Room. They met with the Reunion BRAT and the special event staff at the hotel/casino to ask extensive questions prior to agreeing to this contract. All of the questions were based upon comments and concerns from members who attended our last reunion. After two different inspections, the inspection teams feel that the Desert Diamond Casino and Hotel will be an outstanding venue for our reunion. The food is excellent, the rooms are very nice, and the areas for the BX and Hospitality Room are both easily accessible for all members while also providing enough space for our members.

Members who attended our last reunion also expressed concern regarding fatigue and the extended day while on base. Therefore, our planning for events will reduce the time on base Thursday. We will leave the hotel Thursday morning and go directly to a local cemetery where we will hold a memorial service for Sgt Millard Lehman who was KIA at Binh Thuy. At the conclusion of that memorial service, we will move to another area of the cemetery a short distance away to hold a memorial service for SMSgt Steve Porovich who died at Tan Son Nhut immediately following a mission that he had led on base. 4. **HOME ADDRESS and MAILING ADDRESS:** to mail your confirmation letter. **THE CONFIRMATION LETTERS WILL BE MAILED BY SEPTEMBER 15.**
5. **DAVIS-MONTHAN AFB ENTRY ACCESS FORM: NEW REQUIREMENTS!!!** Please make sure we have your full name as it appears on your **Driver's License** for yourself and all guests. PLUS we will need your DOB, Social Security Number and Country of Citizenship. This information is MANDATORY for access to DAVIS-MONTHAN AFB. **YOU WILL NOT BE ALLOWED ON BASE IF YOU DO NOT PROVIDE THIS INFORMATION.**
6. **TELEPHONE AND EMAIL ADDRESS:** Your contact information is vital to a successful reunion. You will also receive a copy of the attendee roster upon arrival at the hotel.
7. **NAMES OF YOUR GUESTS:** Please provide the first name, middle initial and last name of your guest(s) on the Registration Form as it appears on their **Driver's License, plus their DOB, Social**

**Security Number and Country of Citizenship.** Guests under the age of 18 only need be listed by their legal name and DOB.

# Guest List Procedures

**SUBJECT: VISITOR ACCESS – ENTRY AUTHORIZATION LIST**

**THERE ARE NEW AND ADDITIONAL BASE ENTRY REQUIREMENTS!!** The following comes directly from the 355<sup>th</sup> Security Forces Squadron Pass & ID Section of Davis Monthan AFB: Failure to provide the information will cause denial of entry. **THIS IS NOT A SCAM! IT IS A SPECIFIC REQUIREMENT OF DAVIS-MONTHAN AIR FORCE BASE!!!** “Guests must use their LEGAL information. Nicknames, missing information or incorrect information are not authorized. People will be removed from the list due to not providing valid information for entry onto a Federal installation. List all personnel who require base access. Only use LEGAL personal information (i.e. Legal name, DOB, SSN and DL# or passport, for individuals 18 years of age or older. Guests under the age of 18 only need to be listed by name and DOB.”

**DMAFB must have your complete, full name as it appears on your state driver’s license; NO NICKNAMES OR MILITARY ID CARD NUMBERS. NEW AND ADDITIONAL INFORMATION IS SHOWN IN YELLOW. WE MUST PROVIDE THAT INFORMATION TO THE BASE SECURITY FORCES SQUADRON PASS & ID SECTION so that you can be allowed onto Davis-Monthan AFB with our VSPA Entry Authorization List (EAL). The FULL Social Security Number is required – NOT THE LAST FOUR. Please follow the example below.**

2. Visitors in private vehicles must have current proof of insurance, proof of registration and a current/valid driver's license. Additionally, all personnel and the property under their control are subject to search.

3. We understand that failure to provide any of the information requested WILL result in the denial of an installation access pass. Disclosure of information is voluntary, however; this information is necessary for validation of identity and may result in a non-issuance determination by the issuing authority.

**AUTHORITY:** 10 U.S.C. 8012, 44 U.S.C. 3101.

**PRINCIPLE PURPOSE:** The date of birth is used for further identification of the individual and for retrieving information from files. Routine use could include disclosure to other investigative authorities.

**DISCLOSURE IS VOLUNTARY:** Failure to provide the information to include date of birth, Social Security Number and country of citizenship will result in an individual being denied entry onto DAVIS-MONTHAN AFB.

**ATTENTION VSPA MEMBERS WHO HAVE ALREADY REGISTERED WITH THE REUNION BRAT:**

Please remember that this is a **NEW** requirement and different from the last five years. We apologize for the inconvenience; however, if you have already registered for the reunion, please select one of the following options:

1. Print the new form, complete it and mail to the Reunion BRAT. OR,
2. Call the Reunion BRAT and provide the information via telephone so that she can complete the Entry Authorization List (EAL) for the VSPA. Your information will be secure as she is in the process of completing this information for a reunion being held at another Air Force base.

# 2018 ELECTION OF VSPA OFFICERS

The VSPA's By-Laws call for elections of officers every two years, with all current members being given an opportunity to vote. Current members may vote in person by attending the business meeting at the annual reunion, or by mailing in a written ballot, follows the bios of candidates. Each member may submit only one ballot.

There are six positions up for election: President, Vice President, Second Vice President, Secretary, Treasurer and Historian. The other positions on our board of directors (President Emeritus, Past President and Communications Director) are permanent positions as recognized by our Constitution and By-Laws. All other positions in the VSPA are staff positions appointed by the president and board based upon expertise and willingness to serve the members of the VSPA. Elected officers will be confirmed and installed after the voting is completed at the reunion in October. The term of office of all positions is two years. The positions do not receive a salary and are entirely on a volunteer basis.

VSPA members had until **August 1, 2018** to declare their intention to run for an elected VSPA position. They had to submit a bio and photo for publication in Guardmount. Each person who runs must have been a regular member or life member in good standing for at least two years prior to the election. Board members must have the ability to attend future business meetings that are held at our annual reunions. They must communicate via the Internet and by phone on a regular basis, and must make the commitment to provide the time necessary to serve in the position - none of these are ceremonial positions.

The duties of the elected board positions below are from the VSPA By-Laws:

**PRESIDENT** - The duties of the President shall include, but not be limited to:

- A. Act as Chief Executive Officer and Chairman of the Board of Directors.
- B. Cause to be called all regular and special meetings of the organization.
- C. Preside over all regular and special meetings of the organization.
- D. Enforce the Constitution and By-Laws.
- E. Direct and supervise the operation of the organization.
- F. Prepare and present the Board of Directors Annual Report at the annual business meeting.
- G. Coordinate the confirmation of all appointed staff members with the Board of Directors.
- H. Keep a current folder that includes all official correspondence, records, and official materials assigned to his care and turn over the folder to his successor.
- I. Be an ex-officio member of all committees, except the "Nominations Committee."

**VICE PRESIDENT** and **SECOND VICE PRESIDENT** - The duties of the Vice President and the Second Vice President shall include, but not be limited to:

- A. Assist the President in the discharge of his duties.

- B. Assume the duties of the President in the event of his absence, illness, or call to eternal Guardmount.
- C. Execute the powers and authority of the President, when required, in the absence of the President.
- D. Serve as elected members of the Board of Directors.
- E. Serve as Chairman and member of the Public Relations Committee if a committee is necessary.
- F. Serve as a member of the Scholarship Committee.
- G. Prepare and present annual reports relative to the operation of their respective office at the annual business meeting.
- H. Keep a current folder that includes all official correspondence, records, and official materials assigned to their care and turn over the folder to his successor.
- I. The Second Vice President shall provide oversight for all record keeping activities and assist the President by maintaining hard copy records when necessary.

**SECRETARY** - The duties of the Secretary shall include, but not be limited to:

- A. Officiate when required in the absence of the President and Vice President.
- B. Serve as an elected member of the Board of Directors.
- C. Serve as a member of the Membership Committee.
- D. Be the clerk of the organization.
- E. Be the custodian of all business-related non-financial records and materials, with the exception of: those records which are created and maintained by the VSPA Historian, the VSPA Membership Chairman, the VSPA Treasurer and VSPA Communications Director Don L. Poss; or those records which are required for performance of the duties of the registered agent and liaison with VSPA's tax accountant and tax attorney. All such records shall remain property of the organization.
- F. Take minutes and keep permanent records of the proceedings of all annual Business Meetings and meetings of the Board of Directors.
- G. Prepare and distribute election ballots, if necessary and as required.
- H. Ensure that only members in good standing vote on organizational business. The Secretary will be assisted by the Membership Chairman and the Sergeant-at-Arms.
- I. Serve as official organization correspondent.
- J. Keep a current folder that includes all official correspondence, records, and official materials assigned to his care and turn over the folder to his successor.

**TREASURER** - The duties of the Treasurer shall include, but not be limited to:

- A. Serve as an elected member of the Board of Directors.
- B. Act as Chairman of the Ways and Means Committee if the committee is necessary.
- C. Be the Chief Financial Officer of the organization.
- D. Be the custodian of all financial records of the organization.
- E. Receive and be responsible for the collection of all monies due and payable to the organization.
- F. Have custody of all organization funds, and shall provide for the safekeeping, retention, disbursement, and investment in a manner acceptable to the Board of Directors.
- G. Receive donations on behalf of the organization.
- H. Issue letters in acknowledgement of all donations as required by tax codes.
- I. To work with the President to make such reports and returns as are required by Federal, State and local governments, the Articles of Incorporation, the Constitution, and these By-Laws, including the disbursement of appropriate taxes and fees.
- J. Maintain accounts appropriate to the structure and activities of the organization and in accordance with generally accepted accounting practices and principles.
- K. Keep a current folder that includes all official correspondence, records, and official materials assigned to his care and turn over the folder to his successor.

**HISTORIAN** - The duties of the Historian shall include, but not be limited to:

- A. Serve as an elected member of the Board of Directors.
- B. Serve as Chairman of the Historical Committee if a committee is necessary.
- C. Prepare and present a report at the annual business meeting regarding the history projects completed during the preceding year.
- D. Keep a current folder that includes all official correspondence, records, and official materials assigned to his care and turn over the folder to his successor.

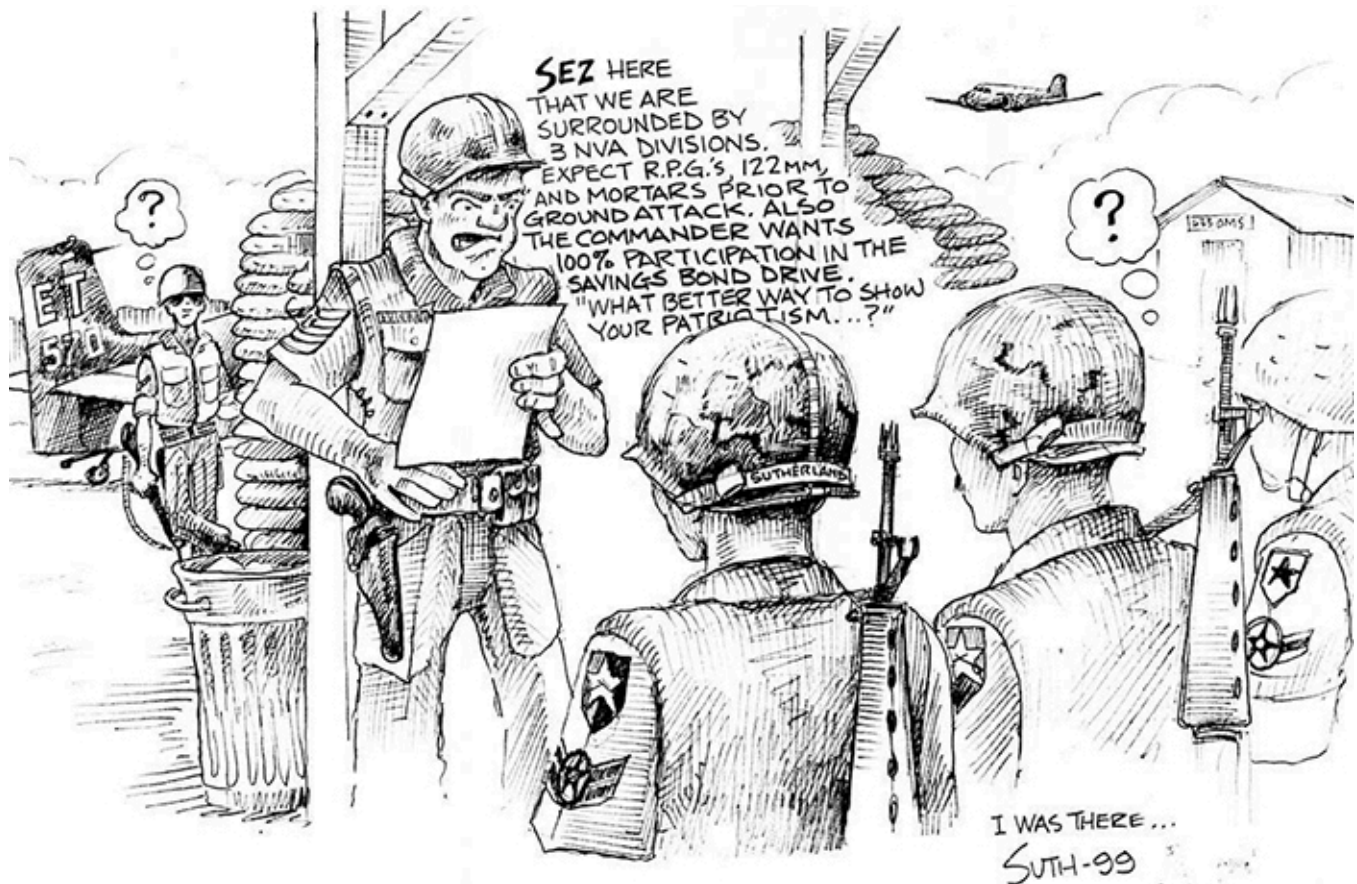

Sawyer AFB, Michigan; 633<sup>rd</sup> Combat Support Group, 633<sup>rd</sup> Security Police Squadron, Pleiku AB, Vietnam; and the 81<sup>st</sup> Tactical Fighter Wing, 81<sup>st</sup> Security Police Squadron, Bentwaters RAF, England. My most memorable experience in the Air Force was defending Pleiku Air Base during the 1968 Tet Offensive in Vietnam.

I separated from the Air Force in 1970 and pursued my college education while working as a warehouse manager for a pharmaceutical and hospital supply company. After graduating from Tiffin University with a Bachelor of Science degree in Criminal Justice, I made the decision to rejoin the military and entered the Army as a Military Policeman. I was assigned to the 554<sup>th</sup> Military Police Company, 385<sup>th</sup> Military Police Battalion, 18th Military Police Brigade, Patch Barracks, Germany; Headquarters U.S. European Command, Protective Service Detachment, Germany; and Forces Command, Law Enforcement Activities, Fort Sheridan, Illinois. My most memorable experience in the Army was leading protective service missions with the Multinational Peace Keeping Force in Beirut, Lebanon.

In 1987, I started my civilian career in federal service with the Department of Army, assigned as the Director/Physical Security Officer, Physical Security and Crime Prevention Division, Office of the Provost Marshal, Ft Sheridan IL. ## MPC - AKA, Funny Money & Monopoly Money

Do you remember the jingle of change in your pocket while you were in Vietnam.” Well, only if it was in a dream or memory from “The World” before you arrived In-Country. That is because U.S. military and civilian personnel could not have or use U.S. currency in Vietnam. In place of the good old “American greenbacks,” everyone was issued MPC or Military Payment Certificates, more affectionately known as Funny Money or Monopoly Money by the troops. MPC Series 681 was in use during most of my tour in 1969 and 1970.

The Bureau of Engraving and Printing produced MPC for the U.S. Department of Defense. MPC originated from the Allied Military Currency (AMC) that was used during World War II. A trial run of MPC was carried out within the Pacific Command in July 1946. The Secretary of War approved the use of MPC and the first MPC series (Series 461) was issued in September 1946. There were thirteen series of MPC designed and/or produced between 1946 and 1973, including four series issued during the Vietnam War (Series 641, 65-68; 661, 68-69; 681, 69-70; 692, 70-73). The DoD has not issued MPC since 1973 and cancelled the program in 2003.

MPCs were elaborately designed products. All notes had four-color faces and two-color backs and the sizes of notes varied according to denomination. Lower denominations of 5¢, 10¢, 25¢, and 50¢ were small in size; \$1 notes were medium size; and \$5, \$10, and \$20 notes were large.

MPC could be used on designated overseas military bases when any of the following conditions existed:

- there was a risk for large amounts of U.S. dollars falling into enemy hands
- the introduction of U.S. dollars into an area could devalue the local currency
- the local government prohibited the use of U.S. dollars by U.S. forces
- the military operation was anticipated to last more than 180 days

If you didn't bring any home with you, MPC is available for veterans who want a souvenir or for collectors; the different notes are available through sources like eBay and even specialized coin and currency brokers. However, you can expect to pay a high price for well-preserved samples. As an example, a recent eBay listing had a 10¢ MPC note selling for \$14.95, or 150 times its face value.

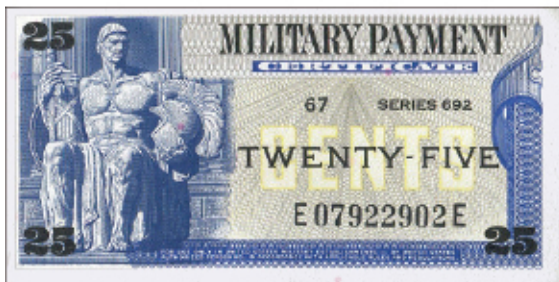

### Airman Who Coined The Now Iconic Phrase 'Good Morning Vietnam' Has Passed Away



Air Force and Vietnam Veteran Adrian Cronauer, 79, of Troutville, VA, passed away on Wednesday, July 18, 2018. Adrian Cronauer served as a disc jockey with AFVN - American Forces Vietnam Network in 1965-66. "Gooooooooood morning, Vietnam!" was Cronauer's signature sign-on for his morning "Dawn Buster" show. His on-air personality and musical selections provided a welcome break from the toils of war for the troops in Vietnam. Cronauer later became the inspiration for Robin Williams' role in the movie "Good Morning Vietnam." After leaving Vietnam, Cronauer went on to a successful career in radio and television broadcasting before operating an advertising business and going into law. Adrian Cronauer was the keynote speaker at the Vietnam Security Police Association's 1998 Reunion in Washington DC. While he may have been in Vietnam before many of us, all of us can recall the enjoyment we got from listening to Adrian Cronauer and the others who followed.

So now we say "Good Night Vietnam" to an icon from our time in Vietnam.

## It Was Just A Flag!

Saturday, January 20, 1970, was just like any other night for the 3rd SPS Charlie Flight at Bien Hoa Air Base. It started off with checking out weapons from the armory and doing the usual pre-shift check of my APC, then attending Guardmount. Guardmount included the usual briefing on local activity and intelligence. There were no unusual threats reported for our area that night. After breaking Guardmount, the other three members of my QRT and I did our final check of weapons and equipment, and we headed out to our assigned position on the east perimeter. Besides being in charge of the east perimeter

QRT, I also drove the APC.

After driving around the southern perimeter of the base, we arrived on the east perimeter and took our usual position behind a berm that was next to a small drainage ditch just north of the “infamous” Bunker Hill 10. The crew checked out the small sandbag-reinforced foxhole that they had dug into the end of the berm a couple months earlier; and we all then settled in for a long, but hopefully quiet shift.

After several uneventful hours on post, we got permission from CSC to take the APC to the motor pool to refuel and notified the area SAT that we would be out of the area. After refueling, we made a stop at the Aerial port terminal to get some coffee and snacks from the canteen before returning to our post. Once back on post, we again settled in for the remainder of the shift and the usual conversations about home and an occasional war story.

Our long boring night was suddenly interrupted at 0456 hrs with that well-known radio call; “10-88, 10-88, Incoming, Incoming!” That was immediately followed by the familiar howl of the base air raid siren. The official records show that Bien Hoa was hit with eight 122mm rockets that morning. Ultimately, it resulted in approximately twenty-six injuries indirectly related to the attack and one damaged C-130.



Since the attack occurred just over an hour before our usual end of shift, CSC directed all Charlie Flight personnel to remain on post longer, as a precaution, for any further enemy activity. An hour or so later, the area SAT came around and delivered the requisite C-Rations. So, now all these pale-skinned night shift defenders are sitting around on post in the glaring sunlight, all keyed up after a night of boredom and late shift attack.

As was often the case, all the guys started telling more war stories and talking about what we could do to blow off steam, show some esprit de corps and let others on the base know that the “Thundering Third” was alive & well as we proceeded back to the squadron compound. All of the guys on the crew said we really should have a flag we could fly from the APC. Unfortunately, our APCs weren't equipped with flagpoles or even a radio antenna to fly a flag in those days. A great idea for the suggestion box, although I don't remember the squadron having a suggestion box either. Finally at about 1000 hrs, CSC released Charlie Flight personnel to breakdown their posts and everyone started to return to the squadron area.

So, now as they say, the names have been changed to protect the innocent as I finish the story. Well, actually after almost 50 years, I have lost all records of those involved and have forgotten the names, so it is just my name.

As mentioned earlier we were normally required to drive the APCs on the perimeter roads going to and coming from posts, but on this particular day I got permission to take a short cut through the base. The route I used took us past the base headquarters building. As we passed headquarters our path was suddenly blocked at an intersection by a 3rd SPS jeep and a very irate Major. Initially I didn't understand why our squadron second-in-command was screaming at me, but it soon became clear. Two of the guys on my crew were sitting on top of the open gun bay hatch holding a flag aloft that I was unaware of. While it wasn't funny or enjoyable at the time, this was the beginning of an even longer day touring the "Chain of Command" from top to bottom and back to the top again several times.

The Major demanded that we give him the flag immediately and report to CSC. The flag he took was a state flag, which had a pattern resembling a Confederate Flag. I know it looks bad, but wait. When we arrived at CSC, we were met by our Flight Chief who briefly chewed me out along with the two guys who were flying the flag. He said that we had to report to the squadron commander's office later and we would be well advised to get a haircut before reporting. After briefly reprimanding me and the other two guys, the Flight Chief laughed and said our biggest mistake was getting caught. He also said he thought it was funny because the flag the guys were flying was his home state flag. Although none of the three of us really needed a haircut, we managed to get one (just in case) before reporting to the squadron commander's office.

The real ass-chewing came in the squadron commander's office. The officers present demanded to know why we were flying the flag and who authorized it. After explaining that it was just something to blow off some steam after the earlier rocket attack, the guys flying the flag said they made the decision on their own. The Major asked if we were trying to cause a race riot and said that we should have known that the flag had the potential of causing a racial issue. He went on to state that a 3x5 inch Confederate Flag had caused a near race riot at the NCO club just a couple weeks earlier. We explained that while two of our QRT teams had been dispatched to standby outside the NCO club as backup for LE personnel, we were never informed of the circumstances. I told the officers if I had known, I would not have allowed the team to fly that particular flag.

When we said it was just to blow off steam and show esprit de corps, the Major asked why we didn't fly some other flag or just fly a white handkerchief from the APC. I said that if we had a US or another appropriate flag we would have flown it, but we never considered a handkerchief or "White Flag" because we had no intention of surrendering to anyone. The end result was we escaped a possible Article 15 or a written reprimand in lieu of the ass-chewing from the commanders, who said they would be watching us for the rest of the time we were at Bien Hoa. I almost got in more trouble when I said that was fine because I only had a couple months left In-Country.

Now here is the funny part of the story. My QRT crew of four included three Caucasians and one African-American. It was the three Caucasians who were observed by the Major initially and had to endure what seemed like a near endless tour of the chain of command. The African-American crewmember was sitting down inside the APC and was not seen by the Major and, therefore did not get in trouble. In fact the rest of the crew agreed that we would not make any reference to him. The most amusing and ironic part of the story is that the guy who brought the flag out on post the night before was the guy who was NOT seen and did not get in trouble. He had borrowed the flag from a hootch mate and taken it with the idea of flying it if something happened.

All four of us had a good laugh about it later and agreed, "*It Was Just A Flag!*"

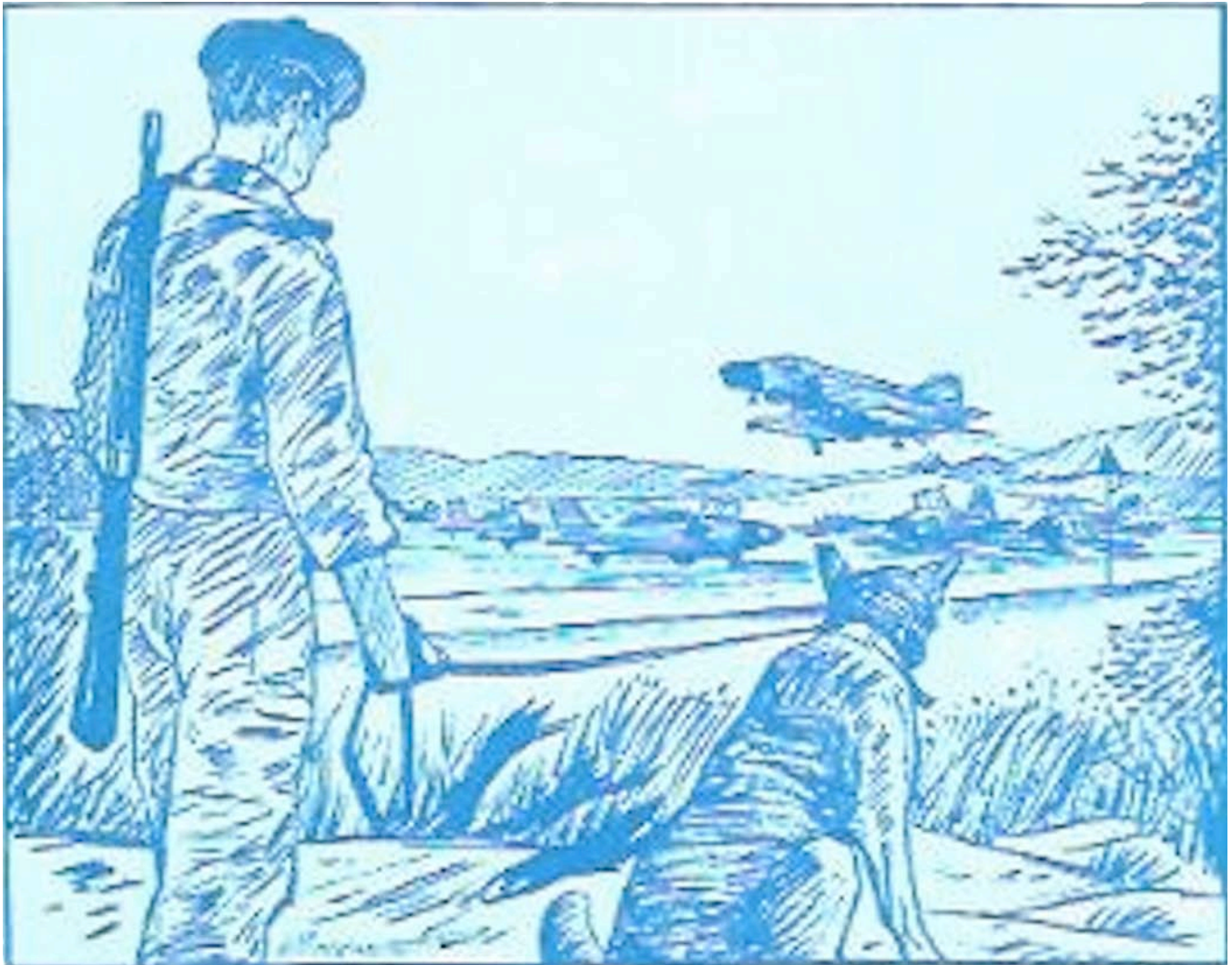
