


THE VSPA SISTERHOOD

Sadly, as age, life and Agent Orange control so much of our lives, it was also the last reunion for more of our beloved members. As we grieve for them, we know how very fortunate we were to see them and share their love and memories. I extend my sincere thanks to Sue Nelson for her assistance to some members of the Brotherhood who experienced minor medical problems.

This year, our reunion in Phoenix will be a time to reconnect and renew our friendships. We have been there before (in 2009) and the Defenders took very good care of us while we were with them at Luke AFB. I am hopeful that more surviving spouses attend and that we will form new friendships with those attending for the first time. We are a family of brothers and sisters who reach out to each other throughout the year because we take care of those who take care of their own. It is who we are as wives and family members. VIETNAM MEMORIAL SERVICE OCTOBER 8, 2021

Good afternoon, it is an honor to welcome you to the Southeast Asia Pavilion on the Grounds of the United States Air Force Academy.

CHAPLAIN JIM STASTNY, please come forward for the invocation.



PRAYER

Thank you, Jim.

This wonderful venue was created as a tribute to the Air Force Academy graduates who served in the Vietnam War. The pavilion was spearheaded by the Class of 1970 as a permanent memorial to those men and women who served in Vietnam and Thailand. Other classes have joined in that endeavor to ensure that the facility is properly maintained. At the conclusion of our memorial service, I encourage everyone to walk through the pavilion to see the honored history of the graduates who are Vietnam Veterans and then feel the spectacular manner in which the facility tells that story.

The following words were written as a Tribute to the Vietnam Security Police Association on the occasion of our Reunion, October 12, 2002:

"Men who served together in good and bad times..., who gave themselves unselfishly to their country..., to their unit and to their mission...; men who stand in later years with hand over heart when the flag of America passes in review...; men whose affection for one another forged lasting bonds of respect and friendship...; these men are the core and heart of our country... They are AMERICA!

Be quietly proud of yourselves and of each other... Take warmth from the ties that bind each of you to the other.

I am humbly proud to have served with men like you.

Robin Olds, Brigadier General United Stated Air Force (Retired) Commander, 8th Tactical Fighter Wing

Brigadier General Olds was a giant of a man and one of the most recognized pilots in United States Air Force history. During his tenure, he was a three-time Ace in World War II, Korea and Vietnam where he shot down 17 enemy planes. He was one of our wing commanders at Ubon Royal Thai Air Force Base, Thailand where he pioneered the Wild Weasel Program. He was also the Commandant of Cadets at this Academy from 1967-1971. Earlier today, we were able to spend some time at a Bronze statue of General Olds that was just recently completed. His letter certainly sums up, in a few words, the bonds that hold our Brotherhood together. In the civilian sector, those feelings of love and pride do not exist in other relationships unless you are in law enforcement or the fire service. As you know, on Wednesday evening, we read the names of our 32 Brothers who stood their final Guardmount; and the 3 Sisters who passed since our last reunion. We will always honor and respect their lives and sacrifice...as we should... We all have benefitted from their friendship and sacrifice. Our









brothers are now remembered forever in our Life Member #111... and we will always remember them as well as the members of our Sisterhood.

Today, we also honor someone else entirely. This ceremony celebrates a group of Air Policemen, Security Policemen and Augmentees who answered their nation's call, then served and fought at locations through Thailand and Vietnam. They served in Law Enforcement, Security, K-9 and/or Safeside. They performed magnificently and never allowed an Air Force base or any other location to be overrun or taken. That is our legacy, our proud history...the history of YOUR service and I am proud to call you Brothers. I am talking about YOU!

There were more than 2.7 million military personnel who served in South East Asia.

Of those, over 303,000 were wounded.

2,338 personnel were missing in action. 1900 are still unaccounted for.

We had over 20,000 Air Policemen and Security Policemen who served in Thailand and Vietnam, with approximately 500 wounded.

Our country suffered over 58,000 Deaths of US troops. And as you know, the Security Police career field suffered 111 deaths.

The Vietnam Conflict was the first war that was brought into the living rooms of America via television. I remember talking with my Mother, prior to her death and asked what it was like having a child in Vietnam... and what was she thinking.....She said it was horrible! She watched the national nightly newscast, hoping and praying that she would not see me on a stretcher being loaded onto a helicopter. I am certain that all of our parents had the same horrifying experience. This war divided America and resulted in an anti-military attitude among many of our citizens. We all remember what it was like when we returned to America... with people calling us baby killers, spitting on us and shouting horrible things about us. I remember returning to Elba, a small south Alabama community. Even my close, life-long friends were stand-offish and treated me differently. It took time for them to realize that I was the same guy they knew. Little did they realize; and I certainly could not explain...why that was not the truth!

As you all know, we left the shores of Vietnam to return to what we called The World...to reunite with our families and loved ones.....

However, Vietnam came home with us. The truth is we did not know how much Vietnam and Thailand would remain part of our lives. For many of us, our lives had changed forever. We were not the immature young men who had volunteered to serve our nation. We were forced to grow up in a hurry and do things unimaginable only months, and sometimes mere days before. Many of us did not carry visible physical wounds; but, we were suffering from PTSD and Agent Orange related illnesses. Most of us were too proud to admit that we were suffering from nightmares, from hypervigilance, from what some called battle fatigue or a form of mental illness. We refused treatment and suffered in silence, refusing to acknowledge the existence of Post Traumatic Stress for many years. That happened because there was a stigma attached to a Diagnosis of PTSD – the "D" very notably indicating word "DISORDER". Thank goodness that has changed. Unfortunately, the result was strained relationships, divorces and very difficult lives led by many veterans. I am proud to say, that today, things are much different. Social awareness of Post Traumatic Stress, advanced treatment and Veteran's understanding of VA treatment availability has resulted in many, many more seeking treatment...and that includes suicide prevention. If anyone has not sought treatment, I urge you to pursue it. It will certainly change your life.





We also brought the war home in the form of Agent Orange. Far too many of us suffer from the effects of Agent Orange. Every year, the VSPA briefs on the various diseases that we have as a result of our exposure. Our own government would not admit that the diseases were caused by Agent Orange for many, many years. While that was a constant problem and often troubled our members, especially as it relates to proof of exposure, they fully realize and admit their responsibility now. If you are suffering, I encourage you to contact a Veteran's Service Officer, seek assistance and file a claim with the VA.

While we have all endured hardship and have experienced multiple issues related to our service in Vietnam and Thailand, I am so very proud of you and absolutely proud to call you my Brothers. We have all sacrificed in some way and answered our Nation's call. You were absolutely the best America had, then and now. I am so honored to be in this distinguished group. The letter by General Olds, which I read earlier, describes you perfectly!

There is another special group that I need to honor today. They are those who are committed to their motto: "Taking care of those who take care of their own."

They live that motto on a daily basis, 24 hours a day, day after day, year after year. They stood by us, raised our children, paid our bills and waited for us to come home. For those who found us later in life, sometimes broken and in need of healing, they loved us and have taken care of us as we take care of our own, as we sought treatment for Agent Orange related cancer, and Post Traumatic Stress.

Our Sisterhood is a wonderful group of wives and companions, who care for us, hold our hand in the night, listen to us cry out with nightmares, and help us function when it seems like we can't make it through the night, or the next day. They push us in wheelchairs and always stand by our side whenever things go sideways. When things go dark, they are there holding things together, helping us realize we are going to be okay. They are our biggest supporters and sometimes need to give us the guidance that saves us. I can readily admit that without my spouse's love and support, I would have suffered a far worse outcome in this life after the war. I know that I am not alone. The Sisterhood is our backbone. Thank God for their support. It is hard to imagine how many of us would have dealt with life without them. Thank all of you for your love and support. We could not have survived this road without you. You are an amazing group!

Our journey as Veterans of Vietnam and Thailand is not over. According to the latest statistics, we still have over 500,000 surviving Veterans who served in Vietnam and Thailand. In this group alone, we have well over thirteen hundred Veterans of that war. We have many who served multiple tours and some who served in both countries. We must continue to preserve our history, tell our story and serve our nation in any capacity possible. I am proud of my Vietnam service and I know all of my Brothers are as well. I am looking forward to many more reunions with the VSPA because this is certainly not our last rodeo.

In closing, I would like to read a poem written by one of our VSPA Brothers, Randy "RAMPS" Stutler who was unable to attend the reunion this year. He wrote these words on July 19, 2008. It is titled: "ONE MORE RIVER TO CROSS":

Echoes softly calling now, within my heart I hear loved ones who have passed away, and many friends so dear.

When we were young and fearless, we'd never count the cost. Life's challenge was no great thing, just one more river to cross.

In Vietnam we stood our ground, young troopers side by side. We bit our lips and hid our fears, and honored those who died.







Through all the years of pain and sorrow, time extracts it's cost, and mortals we are bound to pay, one more river to cross.

Oh, if I could just go back to the way we were back then, laughing, living, full of life, proud warriors and brave men.

But I know deep within my soul, as I count the friends I've lost, there too lies ahead for me, one more river to cross.

CRITICAL INFORMATION!!! PLEASE READ!!!

MAKE YOUR RESERVATIONS EARLY!!!

Our hotel has been inspected by our VSPA President, Jerry Nelson. The inspection was highly detailed, including contract space verifications and a stay in the hotel. His report was OUTSTANDING!

We conducted a survey of members who attended our last reunion in Colorado Springs. We have spoken with many of our members about fatigue and the length of time for our tours. Members who attended previous reunions expressed concern regarding early start times, as well as fatigue and the extended day while on base. More and more of our members have difficulty walking; however, some walking may be required on Friday at the base; however, our extensive planning for events will reduce walking time at the base. The optional tour on Thursday for the Sisterhood will necessarily include some walking. Our goal is to provide an opportunity for a reunion with less physical demands and more time to visit with each other.

The REGISTRATION FEE will be \$210 per person. Our economy has been very difficult for all of us. However, for comparison purposes, the registration fee for our 2019 reunion in Washington, D.C. was also \$210. We always work hard to control cost and sincerely hope that the registration fee is not something that will impact your ability to attend our reunion. The registration fee includes an EARLY BIRD CREDIT of \$25 for those who have a registration postmarked by September 6.

THE FOLLOWING IS A CRITICAL CHANGE TO OUR REUNION REGISTRATION PROCESS. PLEASE READ!

The Reunion BRAT and your VSPA Board of Directors experienced severe impact on planning and preparation FOR THE 2019 REUNION due to <u>late and incomplete registrations</u> that were received long past the deadline.

The impact on the Reunion BRAT and the 2019 REUNION was founded on the long standing VSPA requirement that she prepare the Entry Authorization List (EAL) that we submit to the base.





Andrews AFB needed that list in 2019 so that they could check each name for valid entry. Luke AFB will also need an EAL due to their air assets and their combat readiness mission. The EAL database also affected the Reunion BRAT's ability to create name badges, work with the hotel on meal requirements, room availability, handle last minute additions, assist members with cancellations due to medical issues, and schedule buses on contract for various events based upon the number of participants that varied consistently up until the last few days. The incomplete registrations required the Reunion BRAT to track down members for additional information that was either omitted, or the entire Entry Authorization Data Entry Form was not sent to the Reunion BRAT. In many cases, Board members had to do the tracking and contacting of members.

The impact on the VSPA Board and Reunion Planning Committee consisted of delaying plans with the base, including the meal at the base, working with outside entities who had approval authority over our ability to visit like the U.S. Capitol, Arlington National Cemetery and multiple units at Joint Base Andrews. A variety of other problems occurred that we had to resolve on behalf of our members by contacting them for the Reunion BRAT. THE SAME APPLIES TO OUR VISIT AT LUKE AFB THIS YEAR.

WHEN THIS INFORMATION WAS PRESENTED TO THE MEMBERSHIP DURING THE ANNUAL BUSINESS MEETING, THEY UNANIMOUSLY AGREED THAT THIS PROBLEM MUST BE CORRECTED FOR ALL FUTURE REUNIONS DUE TO THE LAST MINUTE WORKLOAD FOR ALL INVOLVED WITH PLANNING AND COORDINATING A SUCCESSFUL REUNION. THEREFORE, WE ARE IMPLEMENTING AN EARLY BIRD CREDIT ON YOUR REGISTRATION OF \$25 IF YOUR REGISTRATION IS POSTMARKED BY SEPTEMBER 6. FOR REGISTRATIONS POSTMARKED AFTER THAT DATE, THE REGISTRATION FEE WILL INCREASE BY \$25. THE NEW REGISTRATION PROCESS WAS APPROVED BY ACCLIMATION OF ALL REUNION ATTENDEES IN 2019 AND AGAIN IN 2021.

The hotel will prepare a private buffet breakfast with advanced notice and payment through our registration process for our reunion beginning Thursday morning. The fee is \$10 daily per person (Thursday, Friday, Saturday and Sunday ONLY).

Pay specific attention to the requirement for your identifying information on a separate form for the Entry Authorization List. You cannot enter the base without that information.






OUR PROUD AND GALLANT LEGACY

Remember the Pied Piper Story?

Once upon a time, there was a guy who got a sweet gig leading rodents out of town during the great cataclysm known as the Plague. Well, those of us who served in Vietnam and likely Thailand too, had to deal with all manner of animal and insect life during our tours. The "Guymint" had etymologists, Civil Engineers, and base supply, whose purpose in life was to keep us from getting inundated with disease-bearing critters and crawly flying things.



The Supply folks graced us with a variety of bug repellents in sprays and splash-ons in lovely fragrances. When mixed with salt-pill sweat from your pores prior to their clogging, the blend tended to make one kind of slimy and glossy. Some of those bugs might slide off, usually *after* taking their ounce of blood and or flesh.

In addition to mosquitos, one of my favorites was the rice bug. It had a hard exterior and was not a night sleeper. It was attracted to light. If you were riding in an open gun jeep Security Response Team, it could be dangerous. (Remember them Rommel Goggles which most hardly ever wore.?) I was a M-60 gunner on a jeep one night and luckily turned my head ever so slightly just prior to being whacked by a 14 pounder (okay it was several ounces) the diameter of a softball (well maybe a ping-pong ball.) Remember the math class problem: two trains heading at each other at 25 mph and 40 mph, when will they pass each other? Unfortunately, he/she/it was flying, and we were too. Its' hard shell nicked my cheek bone just below my right eye requiring 48 stitches and concussion protocols.... well maybe just some canteen water and a band-aid and no Purple Heart, but that spot will bleed a wad..... I put a tourniquet in place and commenced to stomp the rice out of the assailant which had landed on the floor of my jeep. You don't want to hear my boa constrictor story....

But let's close with the rodent tail, err I mean tale. From time to time, guys would check out a shotgun from the armory and go hunting for those rats which could often be the size of house cats (*well-fed* house cats). This was frowned upon because lighting them up with a round of double-ought buck in the bigger bunkers near the hooches where they hid, made for quite a mess. Guys liked killing them but hated the cleanup detail. Traps worked as long as the trap was anchored (some time you'd see one lugging one behind him). If it was big enough to kill the critter, then CE took 'em away!

Now to the more fun part of this saga. The scene: Bien Hoa AB, Spring 1971, a two-story hooch near the armory across from the SP motor pool and Guardmount area/ ball field. I worked nights and rarely slept in the hooch on a rare night off. One night I did have off, I awoke to a critter scooting along the cement wall of our gazebo hooch by my bunk and I went after him with my bayonet only to miss him. Several days later, I'm in my cube with the fan blasting that wonderful unairconditioned nuoc-mam flavored morning air, attempting to get some sleep after a long Charlie Flight shift. At the entry to the hooch is the cube of my good buddy Sgt Dwain "Woody" Haworth, a B Flight Security guy and Hamiltonian like me.

Suddenly I'm awakened by the sound of loud cussing, hooch-mates cheering, and what sounds like splintering wood and falling timbers. I arise, as did the others in the back of our ground floor abode, to see Dwain in his underwear, wielding the hooch fire axe into the plywood covered wall panel above where he slept. Note that this panel also housed the electrical circuitry for home away from home. We attempted to point this out to Dwain but he was a man with a mission.









Inside this wall was a nest of rats that had convinced themselves they could live nicely out of the rain and sun and feed on GI care packages and leftovers from the hut maid. Dwain said nay nay, and after having no luck with the CE trapping method, decided to take matters into his own hands with obvious success. He was about to put toe tags on the deceased occupants, when the panel shorted, the fans stopped moving and the SP 1st Sgt who was in the area, came to exam the cause of the commotion and carnage. Needless to say, he was less than pleased with having to call in an emergency work order. BUT it did solve the problem and luckily, the CE electricians who love a good story, came with some of their critter killer peeps and it all got cleaned up, the power got restored, nobody got written up, the axe was remounted to the wall, and I finally got some sleep.

So, while Dwain, (who plays the 12-string guitar but not the Lute,) elected NOT to try and lull these rodents out of our hooch with music, I am indebted to him for rendering them rats non-functioning. And it's a fun true (well almost all of it is true) story of the Vietnam veterans' appreciation for Mother Nature and ingenious methods for dealing with Her.

What Are the Aid and Attendance Requirements?

Veterans who need assistance with day-to-day living activities or are housebound may be eligible for the Aid and Attendance pension. You may be eligible for this benefit if you get a VA pension, and you meet at least one of these requirements.

At least one of these must be true:

- You need another person to help you perform daily activities, like bathing, feeding, and dressing, or
- You have to stay in bed—or spend a large portion of the day in bed—because of illness, or
- You are a patient in a nursing home due to the loss of mental or physical abilities related to a disability, or
- Your eyesight is limited (even with glasses or contact lenses, you have only 5/200 or less in both eyes; or concentric contraction of the visual field to 5 degrees or less)

The Aid and Attendance pension can help cover the cost of in-home care, assisted living, or nursing home care. The pension can help pay for home health aides or transportation to medical appointments for homebound veterans.

How Do I Apply for a VA Pension?

You may be eligible for the veterans pension program if you meet these eligibility requirements.

Both of these must be true:

- You didn't receive a discharge under dishonorable conditions, and
- Your yearly family income and net worth meet certain limits set by Congress. Your net worth includes all personal property you own (except your house, your car, and most home furnishings), minus any debt you owe. Your net worth includes the net worth of your spouse.

And at least one of these must be true about you:

• You started on active duty before September 8, 1980, and you served at least 90 days on active duty, with at least one day during wartime, or







- You started on active duty as an enlisted person after September 7, 1980, and served at least 24 months or
 the full period for which you were called or ordered to active duty (with some exceptions) with at least one
 day during wartime, or
- You were an officer and started on active duty after October 16, 1981, and you hadn't previously served on active duty for at least 24 months.

And at least one of these must be true:

- You're at least 65 years old, or
- You have a permanent and total disability, or
- You're a patient in a nursing home for long-term care because of a disability, or
- You're getting Social Security Disability Insurance or Supplemental Security Income.

If you think you might be eligible for a pension, the first step is to gather the necessary documentation. It includes your military discharge papers, marriage and divorce certificates, medical records, and birth certificates for any dependent children.


Once you have the required documentation, you can apply online or by mail.

You will also need proof of your income and any assets you own. The application process can often take several months to complete, so getting started as soon as possible is important.

How to Determine Countable Income

The VA offers different benefits to veterans and their families. One of the most important is the veterans pension, which provides financial assistance to qualifying veterans. The VA looks at their countable income to determine whether a veteran is eligible for the pension. Countable income includes earned income, such as wages from employment, and unearned income, such as interest from investments. **Social Security benefits** are included in countable income.

The VA uses a complex formula to determine whether a veteran's countable income exceeds the maximum amount allowed for pension eligibility. Veterans should be familiar with the types of income that are counted and those that are excluded. By understanding how they assess their income, veterans can ensure they get all the benefits they are entitled to. We hope this guide has been helpful. AN AMAZING HERO BY MARTIN STRONES, COLONEL (RET.) LIFE MEMBER #1011, BIEN HOA 1967-68







On 17 November 2021, we lost an amazing Security Policeman who was a hero in Vietnam. I was his Shift Commander, 'C' Flight, the night shift at Bien Hoa Air Base, Vietnam. The hero was Luther 'Wade' Young, but most people remember him as 'Able 10' his post at one of the several towers in the bomb dump. Able 10 was one of the northern towers near where napalm bombs and other munitions were stored. Bien Hoa was the largest base in the Vietnam war, large because over five hundred aircraft called the base home. For that reason, the base was subject to many rocket attacks by our enemy, mostly called 122s and mortar rounds. According to enemy reports, over 1,300 rockets alone hit the base. At the time there was no incoming alert mechanism or device to detect incoming rounds, so the thousands of members had to dive for cover to attempt to be safe. However, there was a person assigned to the base who had a very unusual special skill. His name was Luther Young.

Luther was the incoming rocket detector who during his tour accurately called in every As his shift incoming rocket attack. commander, I tried every way possible to determine how he was able to detect the incoming rockets, putting others along with Luther in his post, and other ideas, but nothing worked. We modified his post with compass rose markings so he could identify the specific direction of the launching position enabling US Army counterfire and USAF gunships to quickly attack the enemy. At times, Luther called in rocket attacks on nearby US Army bases again assisting US Army counterfire and gunships. His post order stated that because of the hazards of being posted in the ammunition storage area or bomb dump he was to abandon his tower and take cover in the bunker below when the base was under an attack. However, he never took cover, he always stayed in his



tower to look for more rockets. We gained valuable seconds for those on the base to seek cover










by moving the base siren switch to Luther's post. By moving the switch, we felt under most conditions Luther gave members on base 40 seconds to be in the bunker and protected.

One night, Luther pressed the siren and 17 Ranch Hand pilots managed to exit their barracks in that 40 seconds and gain safety as immediately two 122s directly hit and destroyed their barracks and all their personal possessions. Lt. Colonel Kent Miller, Commander 3rd Security Police Squadron, received a letter from the Ranch Hand Commander, thanking Luther for his direct actions that saved each of his pilot's lives.

To demonstrate the impact of Luther's ability and reputation, the number one question I was asked when getting ready for my shift and guard mount by individuals while I walked to posting was: "Is Luther on post tonight?" I could continue with more details of how Luther's actions directly saved lives. There is more to the story. A quiet person, Luther never said much or asked for anything, or even acknowledged his skill. He signed up for a second tour and quietly



returned home for 30 days. We all waited for him to return; however, at the time we did not know his brother, Lonnie Young a US Marine, was killed in Vietnam and Luther was given a reassignment in the USA. Luther never received any form of USAF recognition for his heroic actions.



For eight years I tried to locate Luther to determine why he never returned to Bien Hoa. Finally, with the help of many, I found him working in Kansas City. I called Luther, then flew to Kansas City and personally thanked him for what he did in Vietnam. Without his knowledge and with statements from VSPA Life Member Lt. Col. Miller, John Novak, and myself, plus other evidence of his heroic accomplishments, and special help from VSPA Affiliate Member Major General Mary Kay Hertog, 42 years after his discharge from the USAF Luther was awarded the Bronze Star with 'V' device for his actions. He was an amazing and heroic man who represented the USAF Security Police and Security Forces with great merit and valor. The Vietnam Security Police Association also recognized Luther with the Warriors Medal of Valor of the Native American Nations of the United States of America. I am proud to tell his story.

I Never Thought I Would Outlive You

Letter to my Brothers,

I never thought I would outlive any of you--it never crossed my mind. Not a day passes without one of you popping up in my daily thoughts. Vietnam. Da Nang. Dog handlers, mostly. And we still had fun and made fond memories—and memories not so fun.

Remember the night we got off duty, put our dogs away, and caught a ride to Tent City? The morning cool was nudging 90. After chow hall we were back to our tent—sun just rising a blazing orb that blistered the canvas tent's walls guaranteeing sleep was impossible; way too oppressive a baking heat to sleep. We went outside to our bunker and sat in the shade BS'ing, dozing, and crawling around the bunker following the shade—high noon robbed us of even that. Then sarge caught us out in the open and scooped us up to fortify and fill sandbags; somebodies got to do it and it's you's...or something like that. Funny thing, he drove us over to the kennels and said the President wanted us to participate in the new Vietnam Beautiful Program and plant flowers around the K9 office.

Bouncing in the back of the deuce-n'half, we were all royally...upset, exhausted, and poor-mouthing 'Why Us?' And then someone started giggling and it was contagious and hilarious because of all the above. The plotting began.

Sarge, presented us with about five bags of flower seeds, and told us to dig small holes all around the base of the office, put in a couple of seeds, cover it up leaving a water basin around each one. His mistake was telling his he had an errand to run and would be back in an hour or so and expected it to all be done.

It was. The plotting began.

We dug the little holes spaced about a foot and half apart, with water basins and then on the last hole, we dug one about two feet deep and dumped all the seeds in it. We filled all the basins with water and sacked out inside the office building. Sarge returned ready to break heads but was instead very pleased with our hard work and knew LTC Phillips would be too.

Instead of giving us a ride back to our tent, he told us we should all be bushy-tailed from our naps and to hump it back. We were in a great mood over our little green-thumb revenge.

Sometime later, sarge wondered aloud why no flowers ever grew at the kennels—we did such a great job and all. I told him I thought the reason was all that Vietnam crappy soil and the Vietnamese using it for toilets. He thought about it and said that sounded about right.

Many other fun things happened; and bad things, along the way. Sgt. Jensen was KIA in July, and in January, JB Jones was KIA. Woodward later and another guy. Maxie couldn't handle that JB was killed and was sent back home. He disappeared. Later, there were ten or so other deaths at Da Nang; a couple of new guys got sick and died within 1-5 days of arrival, dying on the hospital ships in the harbor—we never met them or even knew their names for years—and one or two drowned. I DEROS'd and gradually so did you all.







Three decades passed, and then you started dying. Phil Norwich passed away in 1997, heart attack and AO related. We didn't know that many of us were killed in Vietnam by Agent Orange that would follow us home to finish the job. Tom Baker, 2007; Gary Eberbach, 2017; Gary Knutson, 2020. And yes, there were others. And when I go for walks, I sometimes feel your shadows in memories, and smiling at some; tearing at others. I'm old, you know, and a great-grandpa now.

Brotherhood is not a club to veterans. I can still see your faces and hear some of your voices in my dreams. I've often wondered if our dogs went to heaven. If the lion will lay down with the sheep in peace, I think there may be a place for Blackie, Rex, Eric, Lucky, King, and all the others.

None of us left Vietnam as we had arrived. We were changed and Vietnam couldn't be undone. We remember you each day, each night, in our hearts, in our minds, in our souls. It will always be so this side of The Wall. Our Brotherhood will someday have crossed over to the other side, and once there, maybe we could plant some flowers.

SPECIAL PRESENTATION BY CARMEN K. McGINNIS, NATIONAL SERVICE OFFICER AND COLORADO REGIONAL SERVICE SUPERVISOR FOR DISABLED AMERICAN VETERANS (DAV).

Ms. McGinnis is retired from the United States Marine Corps and has several years of experience representing Veterans and facilitating claims (AT NO COST) that she has filed on their behalf with the Veterans Administration. She emphasized that certified Service Officers through the DAV, American Legion, and other organizations DO NOT CHARGE FOR ASSISTANCE. Veterans do not have to pay to file a claim with the VA and should not use the VA for assistance in filing their claim due to the adversarial nature of the claims process. She presented extensive information specifically tailored to Vietnam Veterans who have Agent Orange Related health issues and disabilities, as well as hearing impairment, hypertension and PTSD. At the conclusion of her presentation, she attended the meeting of the VSPA Sisterhood to present information tailored to wives of Vietnam Veterans and how they may assist in the claims process.

an active duty Security Forces Squadron, or an independent destination chosen and voted on

by the general membership at the annual business meeting."

- Reunion sites are selected two years in advance so that planning by the VSPA can begin early. We need to be able to adjust to events in the chosen area. If we are being hosted by a Security Forces Squadron, they can begin early and have the time necessary to adapt to active-duty operational requirements.
- The reunion site for this reunion in Colorado Springs, Colorado was selected in 2018 and postponed to 2021 due to the COVID-19 Pandemic.
- As in the past, the 2022 reunion will be held in October, the Wednesday through Sunday before the Columbus Day holiday (which is always the second Monday in October). The dates are October 5 - 9, 2022. The sites selected at our 2019 Reunion were:

- **8.6 BX SALES REPORT** by Van Digby. The BX has been highly successful at every reunion for several years. Van presented information on new items of memorabilia that are available in the BX. He also requested that the members approve payment for transportation of the BX to and from Colorado Springs. The membership unanimously approved his request.
- **8.7 WEB SITE REPORT** by Don Poss, Communications Director. Don presented information on recent updates and the conversion of the membership database to make it easily searchable for members. He also presented information on the need to update all base histories, squadron lineage, articles, stories and poetry to downloadable PDF files to ease the process of research and the preservation of our history.

Steve Gattis added the following to the web site report, reminding all present that our status as a Tax Exempt Military Organization of War Veterans requires that we follow IRS Rules and Regulations regarding the prohibition of political activity in support of or against specific candidates for office. The VSPA does not pay income tax and all donations to the VSPA are tax exempt for donors. Our exempt status is the equivalent of the government and the public paying us to conduct our business on behalf of our membership. We cannot receive the benefit of tax exemption if we engage in political activity as an organization. Therefore, the VSPA and other organizations like the VVA cannot advocate for or against candidates for political office, especially during highly contested elections or the current volatile political climate. The VSPA must demonstrate compliance by removing political comments from our bulletin boards when members attempt to organize votes or begin speaking for or against candidates. 


Lost and Found (Comrade and Friend)

Mike Kennedy, Life Member #35, Bien Hoa AB – 69-70

The story of a brotherhood and friendship made in Vietnam, but almost lost after coming home.

I arrived at Bien Hoa Air Base on 1 MAY 1969 to begin my tour of duty with the "Thundering Third" 3rd Security Police Squadron. Like the troops that stepped off the American Airlines



The first week of my orientation period, I bunked in the senior NCO hootch as arrangements were made for my permanent hootch assignment. I felt privileged having such great accommodations as a lowly E-4, but shortly after I moved to hootch #36, which I would call home for the next year. I ended up sharing a cubicle with Sgt Robert "Gary" Whisnant who had arrived about a month before I did. We were assigned to nights in Charlie Area (east perimeter). Like most other SPs, we started out working the bunkers, including the infamous Bunker Hill 10 (Tet '68).









We then started working other assignments like SAT and QRT but didn't always work together. After a couple months we settled into more permanent assignments. Gary went TDY to another base for Mortar School and returned to work Twinkle III, the Charlie Area Mortar Pit. At about the same time I trained to drive the original 3rd SPS M-113 Armored Personnel Carrier, affectionally known as "Fluffy." Fluffy, an older, gas-powered APC was later traded to an Army unit when the 3rd SPS received four new diesel-powered APCs in June 1969. I then started working fulltime as the driver/team leader for the Charlie Area QRT.

Although Gary and I seldom worked side by side for the rest of our tours, we spent most of our off-duty time (what there was of it) hanging out together. Many hours were spent listening to music on Gary's Teac or Akai reel-to-reel tape recorder, talking about life at home, semi-regular trips to the NCO club or enjoying the occasional flight parties/BBQs. These days I do veteran interviews at local high schools, and I often refer to that big tape deck as our version of an iPod when I am showing students my photo album.

Neither Gary nor I can definitively say what we were doing in this photo, our best guess today is that it had something to do with the Alabama Crimson Tide football program. Gary has been a lifelong diehard fan of Alabama even though he is from North Carolina. That now creates some interesting conversations since I favor the USC Trojans!

After completing our respective tours and we DEROS'd stateside, Gary and I lost contact with each other. I moved several times after I was discharged and during one of those moves, I lost any records I had with Gary's address. I tried several times over the



years to locate Gary. In 1999/2000 I came up with about ten addresses across the country for people with the same name. I sent letters to each one, hoping that I would stumble onto my old friend. Sadly, I never received a reply to any of the letters. Today's advances in technology have made it easier these days to track someone down using the Internet, but it still wasn't that easy around the Y2K timeframe. Having failed to get a response to the letters and not finding any other leads, I pretty much gave up on my search and figured Gary and I would never reconnect with each other.

Fast forward to 2015/2016, I got up one morning and did my usual routine of feeding the dogs, turning on the local news to see what Earth shattering or mundane things had occurred since day before, and checking my email.

To my amazement as I was scanning the list of unopened messages, I was shocked to see a name that I thought of almost daily but had not read anywhere in many years. I sat there staring at my computer screen as I read the sender's name "Robert Whisnant." I could not believe what I was seeing and just stared at it for a minute. I had always remembered my friend as Gary, never actually using his first name, so I thought at first that it might just be a coincidence that someone had the same last name.

So, after a double take, I opened the email and as I read the email, I thought to myself that I had written it because Gary's message read almost exactly the same as the letters, I had mailed across the country 15 years earlier. Gary's email basically started off by saying "You may not remember me, but if you are who I think you are, we served together in Vietnam." I definitely knew who he was and had never forgotten him.

Gary's message continued by saying that he had actually found my name on the VSPA website while searching the Internet for me. He found my email address and took the chance that I was the right person. As I found out a couple years ago, there is a chance that he may have connected with another Mike Kennedy who also served in









the Air Force as a Security Policeman. Although not an active member this Mike Kennedy had contacted me to arrange to transfer his VVA membership to the Inland Empire chapter that I belong to.

Needless to say, that once Gary and I connected, we at first spent many days sending multiple emails back and forth every day, catching up on where our lives had taken us since the last time we spoke in March 1970.

I learned that Gary had never left his hometown in North Carolina, which I had totally forgotten over the years because none of the addresses I sent letters to were in North Carolina. In another funny coincidence I was talking to my wife Debbie as I was reading one of Gary's first emails and she asked where he lived. I said he lives in Morganton, North Carolina. She told me I had to be kidding because her dad had been transferred to Morganton, NC for his job when she was a kid and they lived there for a year or so.

Once Gary and I reconnected we tried to plan a real reunion, but something would happen to prevent it. It was a long time coming (too long), but with COVID winding down and organizations rescheduling planned events like VSPA's 2021 Colorado Springs Reunion, I decided time might be running out on opportunities for us to get together.

VVA scheduled its National Convention in Greensboro, NC just a month after the VSPA Reunion. I decided I had to make the trip to Greensboro. After making my reservations, I sent Gary a note and said I was heading his way and hoped we could find a way to get together. Gary said Greensboro is less than two hours from Morganton and he said he and his wife Linda would come to Greensboro for a couple days so we could see each other.

Finally, on 3 NOV 2021, almost 51 years after we last saw each other in Vietnam, Gary and I had a great reunion at the Sheraton Greensboro at Four Seasons hotel in Greensboro, NC. In between the VVA convention activities that I was committed to, my good friend and comrade Gary and I spent many hours over three days reminiscing about our shared adventures in Vietnam, retelling old war stories, and no doubt boring Linda at times even though she claimed she enjoyed it all.

I am hoping that my good friend Gary and I can get together again, I have no idea if we will ever have that opportunity again. In any case we continue to communicate regularly, and we have our great new reunion memories to go along with our Vietnam memories that will stay with us forever.

Thank You Gary for being a brother, friend, and a part of my family.
