74 Rockets and Mortars; US KIA, 0; US WIA, 15; US Destroyed Aircraft, 2; Damaged Aircraft, 11; RVN KIA/WIA 0; Aircraft Destroyed-Damaged, 0; VC/NVA KIA, 16; VC/NVA POW, 1.

SOUNDED AT T FELL OUT OF BES THINKING IT WAS WOTHING .. IT WAS JUST THE RECALL BELL. SOMEONE CAME IN YELLING A KIN WAS SHOT, BUT WE'VE HEARD THAT BEFORE AND IT'S BEEN FALSE, WHEN WE GOT TO CSC IT WAS DECOURED A K-7 HAD BEEN. I ENDED UP ON THE EAST PERIMETER AS PART OF A BLOCKING FORCE - THERE WAS A LOT OF SMALL AMIS FIRE BY 1-3 AND THEN I HEARD THEY BOT 3 KIA - AT THIS POINT I KNEW SOMETHING WAS GOING ON, SOON AFTER I HEARD A. MORTAR BARRAGE HITTING THE FLIGHT LINE AND SAW THE FLAMES AND SMOKE AS WELL AS LARGE EXPLOSIONS - SOME OF THE MORTAR WERE COMING IN RIGHT OVER MY HEAD-THE RADID WAS ALIVE WITH GOYS VOICES- EVERY SECTION ON THE BASE WAS HAVING CONTACT WEAPONS COTEE FIRING EVERY WHERE . WE . GOT BACK TO CSC AT 7:00 AND HAD TO GO OUT AND SWEEP THE HOPE AREA - NEBREWA BACK TO CSC WHERE WE SANTHE THREE DEN VC BODIES - BACK TO THE BES AT 10:00 TO SLEEP UNTIL 12:15 - WORK AT 1:30 - SAW FOURTEEN BODIES SPREAD OUT AT CSC THIS TIME - I HAD THE BEACH GATE AGAIN BUT ALL WAS QUIET- I WAS TOLD WE WERE HIT WITH MORTARS AND ROCKETS BUT DON'T KNOW HOW MANY. GOT OFF AT 9:30 AND GOT IN BED CHIDISI

"THE 1:37 ALARM **SOUNDED** AT **AND FELL OF** BED **THINKING** IT **OUT** WAS **WAS JUST** NOTHING. IT **THE** RECALL BELL. **SOMEONE CAME** IN **YELLING** K-9 WAS SHOT, BUT WE'VE **HEARD THAT** WHEN IT'S **BEFORE AND** BEEN FALSE. CSC TO WAS WE **GOT** IT **DISCOVERED** K-9 Ι **ENDED HAD** BEEN. UP ON THE PERIMETER AS **PART OF EAST** A **BLOCKING** FORCE - THERE WAS A LOT OF SMALL ARMS BY I-3 AND **THEN FIRE** I **HEARD THEY** GOT 3 KIA - AT THIS POINT I KNEW SOMETHING WAS GOING ON. SOON AFTER I HEARD **MORTAR** BARRAGE **HITTING** THE **FLIGHT** LINE AND SAW THE FLAMES AND SMOKE AS AS LARGE EXPLOSIONS - SOME OF THE MORTARS WERE COMING IN RIGHT OVER MY HEAD - THE RADIO WAS ALIVE WITH GUYS VOICES - EVERY SECTION ON THE BASE WAS HAVING CONTACT WERE FIRING EVERYWHERE. W_E WEAPONS GOT BACK TO CSC AT 7:00 AND HAD TO GO OUT AND SWEEP THE HOEL AREA NEG RESULTS. BACK TO CSC WHERE WE SAW THE THREE DEAD VC BODIES - BACK TO THE BKS AT 10:00 TO SLEEP UNTIL 12:15 - WORK AT 1:30 - SAW FOURTEEN BODIES SPREAD OUT AT CSC THIS _ [BEACH HAD THE GATE TIME **AGAIN** ALL **QUIET** I **BUT WAS** WAS **TOLD HIT** WE **WERE WITH MORTARS AND** DON'T ROCKETS, BUT **KNOW HOW MANY** NVA WERE **KILLED** ON THE **PERIMETER** GOT OFF AT 9:30 AND GOT IN BED BY 10:30."
