Reference your letter of 25 May 1995 to Maj Gen Normand G. Lezy, Director, Legislative Liaison, on behalf of your constituent, Mr Robert G. Anisko.

Attached is a photocopy of DAF Special Order GB-58, dated 1 March 1966, that awarded the AFOUA to the 34th Tactical Group. We regret that we were unable to locate any personnel rosters in either the records of 34th Air Base Squadron, or the 6220th Air Base Squadron. However, we have provided pages from the history of the 6220 ABS that mention "key" personnel which were assigned to the unit. There were no similar entries for the 34 ABS.
