Sir, I am the webmaster and designer for two large veteran websites (USAF Air/Security Police Squadrons: http://www.vspa.com, and all military services: http://www.war-stories.com). For 20 years I have encouraged members and websites visitors to update their DD-214's and to check with the VA to see if they are entitled to benefits due to their service in the Air Force. I now find myself taking my own advice. I have filed a claim with the VA concerning my service at Da Nang Airbase, South Vietnam, from 1965-1966. Da Nang was ground-zero for Agent Orange (home for Operation Ranch Hand) and other chemicals, and I have submitted a request for an appointment with the Agent Orange Registry, which is pending. I served with the below USAF Air Police Squadrons as a K-9 Sentry Dog Handler, and am currently being treated for PTSD. Many of the men I personally served with have passed away since 1997, and the one-witness to four of my seven "stressors" is in the last stages of Parkinson's and does not remember his wife's name. I introduced they and they have been married now 47 years (as have my wife and I).
