Donald Mullen - My Story

Born Donald Robert Mullen. May 19, 1945 in a small town in Maine. At the age of six, I lost my Mother to Bright's Decease. Having three older brothers was very hard for my Father to support us, as he was a Maine State Policeman.

I was adopted by my Uncle and Aunt. He was a Navy Pilot so we moved a few times. He flew with the

Blue Angels when we lived in Texas. After 7 years, I went back with my father as he had remarried. He did not want to split up the boys.

At the age of 19, I joined the Air Force for 4 years. I was stationed in Maine at a SAGE Base for a couple of years then in 1967, I went to Bien Hoa, Viet Nam with the 3rd SPS. On May 12, 1967 at 1:00 in the morning my Hut #59 was hit with a rocket. I was in the hut at the time. I was pulled out by someone I do not know. While in the hospital I was told I was bleeding from my ears, nose, legs and back. I had trouble with my hearing for a long time after and still do. I had some shrapnel in my back and hands. I was thrown a distance in the hut. I had pulled two mattresses over me just as the rocket hit. I have received two Purple Hearts for this. I had lost everything in my hut, including my camera, which I had taken a lot of pictures of movie stars who came to our base and LBJ. As a result, I now have limited use of my right arm and I have Tinnitus.


When I returned to the United States, I was stationed at Maxwell AFB in Alabama. About 3:00 in the morning on a Security Post I was on, I had a nervous breakdown where I tired to commit suicide. They strapped me down in a plane and flew me to a mental hospital at Eglin AFB in Florida where I spent time to get better. After a while they sent me back to Maxwell where I worked for a few months at the Motor Pool inspecting vehicles. They would not allow me to carry a gun anymore. Life after coming home was very tough. Lots of people teasing me. I had gone to Tech School for electronics and I worked for many years in Avionics.


I am retired now. I am 71 now and single. I was married twice but was not good to them due to my PTSD. I have no children. My health is good but the memories will always be there. I attended the VSPA Reunion for the first time in Tampa Florida. I still try to talk to the Vets on Facebook. Well, this is my story. Hope others will do the same.

FROM YOUR NEW SERVICE OFFICER JAIME A. LLERAS, Life Member #887, Binh Thuy AB - 1970



I am honored to have been selected as the VSPA Service Officer in November 2016. I'm looking forward to providing you with the most current information on Veteran's rights, claim process and updates on what the VA is working on that affect us all.

First, let me start by reminding you that, if you haven't yet: 1) Visit your VA or Primary Care doctor ASAP to have your prostate checked during a physical or lab work (PSA Test). This simple test(s) can be a life saver;

2) Register with the VA's Agent Orange Registry. According to the VA, the Agent Orange Registry health exam alerts veterans to possible long-term health problems that may be related to Agent

Orange exposure during your military service in Vietnam. The registry data helps VA understand and respond to these health problems more effectively. To register, contact your VA Environmental Health Coordinator about getting an Agent Orange Registry health exam as soon as possible.

Secondly, here's an update on a current (and scary) issue the VA is working on:

FROM THE VA

The Department of Veterans Affairs (VA) recently acknowledged that certain diseases showing up in Vietnam Veterans are directly linked to Liver Flukes. Thousands of Veterans from the Vietnam era are coming down with rare cancers, many of which are the result of Veterans having consumed parasitic fish while serving in Vietnam. The VA is seeing an increase in bile duct cancer, Cholangiocarcinoma, and liver cancer amongst Vietnam era veterans.

What Are Liver Flukes?

Liver flukes are parasites ingested in raw or under-cooked freshwater fish. They are endemic in parts of Southeast Asia, including Vietnam, along with other areas, mainly in China and South Korea. Some 25 million people are infected with the worms. Liver flukes die when frozen, but they can survive fermentation or pickling. Visitors traveling in endemic areas can also be infected.

What is Cholangiocarcinoma, and How Do Liver Flukes Cause It?

Cholangiocarcinoma is a rare cancer that affects the bile duct. Liver flukes are a risk factor; others include hepatitis B and C, cirrhosis and bile duct stones. After the worms are ingested, they can live for more than 25 years in the bile duct, causing inflammation and scarring that can eventually lead to cancer. The disease is difficult to treat, with many victims dying within months of diagnosis. A patient typically does not experience any symptoms, such as jaundice, until the end stages.

Can This Cancer Be Treated?

Bile duct cancer is unusual because it can be prevented in some cases. Pills can wipe out liver flukes early on, but the medicine is not effective in later stages after the worms have died and scarring has occurred. Surgery is possible in some cases, but the survival rate is only about 30 percent for five years, said Dr. Gregory Gores, a gastroenterologist and executive dean of research at Mayo Clinic. Affected countries, such as Vietnam and Laos, have not conducted extensive research to determine the extent of the problem. The world's highest rate of cholangiocarcinoma - about 84 new cases per 100,000 people -

is found in <u>northeastern Thailand</u> where many people eat a popular raw fish dish. In the U.S., cholangiocarcinoma is extremely rare, with around 1.7 in 100,000 people diagnosed each year.

What Is The Connection to Vietnam Veterans?

Men and women who served in the Vietnam War and ate raw or poorly cooked fish, sometimes while on patrol in the jungle after their rations ran out, could have been infected by liver flukes. Left untreated, they can experience symptoms related to bile duct cancer decades later. Because the disease is so rare and awareness about liver flukes is poor in the U.S., many veterans may not be aware of the possible connection to their service time.

Finally, if you need further information about this or any other diseases affecting Vietnam Veterans, contact your nearest VA clinic or facility. And, please don't try to work on a claim with the VA on your own. Always get help from a certified Service Officer from one of the several Veteran organizations such as the Disable American Veterans (DAV) or the Vietnam Veterans of American (VVA). AGENT ORANGE PROSTATE CANCER

As life would sometimes dictate, we make decisions that can affect us years later. When I was at Kunsan Air Base, Korea in 1967, Paul Shave and I volunteered to go to Vietnam, something we did not have to do, but wanted to do. While others were leaving for bases in Europe, my decision was founded on the loss of friends from home who had been killed in action, and a sense of duty that drove me to follow in the footsteps of my father to serve my country during war.

The year in Vietnam was tough, but ended without being wounded or seriously injured...or, so we thought. Some injuries cannot be seen, and some do not become evident for many many years. I was diagnosed with Agent Orange related prostate cancer last October, a week after our reunion in Florida. Thankfully, I had followed studies on Agent Orange and had led prostate cancer discussions at VSPA reunions for several years. My PSA and biopsy-based Gleason scores were very low because I had pushed to have annual PSA tests and anticipated that I might have a problem since <u>Vietnam Veterans have a 2 ½ times greater probability of contracting aggressive prostate cancer</u>. The very early diagnosis made surgery unnecessary. Radiation treatments started on January 9, five days a week for eight weeks. With highly skilled oncologists, I should be cancer-free in at some time in the future, with long-term survival and a permanent cure that will be monitored by frequent PSA tests. The 40 radiation treatments ended in March. My first follow-up PSA test showed that it had been reduced by 50%! The next test is in July and will, hopefully, be lower.

As I write about having Agent Orange prostate cancer, something I knew could happen, I also think about what it was like to be a cop in Los Angeles County, knowing that being injured or killed in the line of duty was a possibility, something I regularly talked to my deputies about in terms of training, officer survival and estate planning for their survivors if something bad happened. Sadly, I lost over 30 friends in 32+ years, men and women who died or were killed in the line of duty. It happened, although my friends and partners never thought that their name would be on the peace officers memorial, just like our brothers in Vietnam and Thailand did not think that their names would be on a memorial like The Wall in Washington.

Prostate cancer is real. It will KILL you. All of us have lost VSPA buddies due to Agent Orange related cancers. When I talk about it at reunions, and ask if there are members who have had a PSA test or a digital rectal exam, there are always some VSPA members who have not been tested. Thankfully, that number gets smaller every year. There are always several members present at reunions who have been tested, diagnosed, treated and have survived! They are very willing to share information and they always encourage members to get tested because Agent Orange related prostate cancer will kill you. Even now that I have had a biopsy and have a positive diagnosis of prostate cancer, and absolutely knew it was a high probability because of exposure to Agent Orange, I still find it hard to believe that it happened to me, and I got tested every year.

I want to thank Jack Smith, Don Graham and Gary Jones for their willingness to talk about something that is consistently perceived as deeply personal. They take care of their own by talking about their treatment and survival. Although I have conducted a lot of personal research and have seen several doctors who provided excellent information, Jack, Don and Gary provided perspective that led to good decision making for me, for Lise, and for my children and 11 grandchildren. Get tested. Catch it early. Give yourself some options rather than letting Agent Orange take you to the grave. Get tested. Do it as an act of love for your families.

Since I was diagnosed with cancer, several of my VSPA brothers have also been tested. Thank you. Some were very lucky and had low PSA tests. One had a high PSA and a digital rectal exam that indicated a potential problem. The combination of both tests, just like mine, indicated a distinct need for

further investigation with a biopsy. The biopsy came back positive for prostate cancer. That brother and dear friend is John Risse. He discussed all of this with me and notified the VSPA on the Bulletin Boards. John was exactly 20 days behind me in the treatment program. Thankfully, his treatment has also been completed and his PSA has also been reduced. I send my best to all of you. PLEASE GET TESTED.

PROSTATE CANCER CAN KILL YOU!

I noticed many Vets were in wheel chairs and were wearing caps. I welcomed home a fellow USAF Vet who was stationed at Da Nang in 1968-69. We talked for a few minutes about Nam.

While we were waiting, the wedding party arrived and the minster asked them a few questions. It was her first time to marrying someone in a VA hospital. She told us she wore 'ten minute high heels, then back to flats."

I thought about many of us still being able to function in the world today. These men fought for their country too and today brought something different into their daily routine.

The 924th Life Member just signed up at this reunion! Paul thanked members for their donations of \$15 to support members who cannot afford to pay their dues.
