
## PART 3 - LEOSA - HR 218 The Law Enforcement Officer's Safety Act and AFM 31-125 An Update by Steve Gattis, VSPA President Emeritus

This article is Part 3 of the LEOSA Update and builds on the information provided in our last two issues of Guardmount. Many of our VSPA members who retired from Department of Defense law enforcement, the Air Force, Air Force Reserve or Air National Guard as Air Policemen, Security Policemen or Security Forces will soon have the opportunity to apply for credentials to carry concealed firearms pursuant to H.R 218, The Law Enforcement Officers Safety Act (LEOSA).

The Air Force has implemented Air Force Manual AFM 31-125 that was signed and dated 22 April 2014. Headquarters Air Force Security Forces Center at Lackland will be the issuing agency and approval authority for all LEOSA identification cards for retired personnel. The Security Forces Center recently announced:

"The on-line application process to submit your forms for <u>LEOSA</u> credentials is <u>NOT</u> <u>READY</u>. Air Force Installation Contracting Agency (AFICA), Wright Patterson AFB, OH, has selected a contractor to issue LEOSA credentials to past/present AF law enforcement personnel. Congratulations to Defense Consulting Services (DCS) on their selection. The AFSFC and DCS staffs will now finalize the process of developing the on-line application process and credential. We will begin beta testing of this process in the very near future and hope to have examples of what our credential will look like shortly. I continue to ask for your patience as we work diligently to move this process forward. Our estimated start date for credential issuance remains 1 Sep 14 with the cost of a 926B credential at \$140 and the cost of a 926C credential at \$160 which will be valid for 5 years. We will continue to keep you posted on our progress."

For VSPA members who might be covered under LEOSA as a retired military law enforcement officer with a minimum of TEN YEARS OF SERVICE WITH APPREHENSION AUTHORITY, it is very important to note that the DOD policy and the Air Force procedures DO NOT confer any rights or privileges to carry a weapon or anything equivalent to the authority of an active duty law enforcement officer. The policy only delineates the qualifications that a retired officer must meet in order to receive an ID and carry a weapon, if qualified. There are many issues that are yet to be resolved by the Air Force and the newly selected contractor to issue the credentials. If you

As I have written this column for several years now, you may have concluded that I am writing about my current life status. There is a reason it is called "Ramblings of an Air Force Brat". I truly appreciate your indulgence.

Once again, I find myself in the midst of change. I am not a big fan of change, in fact, I really enjoy routine. The same thing day after day does not bore me, it makes me feel secure. I don't like feeling insecure, so I desperately hold on to what I know. News flash...it does NOT work. Change will come. You can't run, you can't hide, you can initiate it or have it thrust upon on you, but friend, it will definitely come.

Not all change is bad. It is all pretty scary though. Change may bring you great happiness: a new relationship, a new baby, a new job, a new home. The changes we anticipate with joy don't set us on our heels.

Dear VSPA Family,


Thank you so much for your support of Sarge's Café. We are now fully recognized by the IRS as a tax exempt 501(c)(3) charitable organization. Our summer camp mission was a great success. The week of July 14 through July 18, we served lunch to students attending a day camp at Restoration Academy in Fairfield, Alabama (<u>www.restorationacademy.org</u>). Each day there were approximately 35 campers. Through generous donations, Sarge's Café provided lunch, an afternoon snack, and on the last day of camp, a take home lunch for each camper.

Our second mission is underway. We have set up a small food bank at Restoration Academy. Currently, we have 20 sack lunches of chef Boyardee, bottled water, pudding, animal crackers, and goldfish available to students who do not have a lunch. We will expand that to maintain 50 sack lunches on a regular basis.

October 14, 2014, I will be working with the 3<sup>rd</sup> and 4<sup>th</sup> grade classes on their "service day". The students will be decorating and filling the lunch bags for the food pantry lunch program and Sarge's will sponsor a pizza party lunch to celebrate serving.

We will also initiate Sarge's version of a weekend food program providing nonperishable, kid friendly foods for 2 breakfasts, 2 lunches and 3 dinners to the children who do not have enough food at home. With the help of the teachers, staff, and counselors at RA, we will be sure that the children in need will be discreetly provided meals for the weekend. Our ultimate goal is to expand the food bank at RA to provide non-perishable foods to the families of RA students with the greatest need.

## Vietnam Security Police Association 20<sup>th</sup> Annual Reunion Shreveport, LA – October 8-12, 2014 Barksdale AFB, Louisiana

The reunion will be held at the Holiday Inn Shreveport Airport West hotel, 5555 Financial Plaza, Shreveport, LA, 71129. Our contract room rate is \$89 per night, plus taxes. The rate includes FREE breakfast each morning for up to two (2) people per room and complimentary FREE Shuttle Service to include the airport (call for the shuttle: 318-688-3000) and anywhere within a five mile radius of the hotel. The room rate is good for three days before and three days after the reunion. Parking is FREE. You will have to specify your choice of a smoking or non-smoking room. The room rate is a \$26 reduction per night when compared to the hotel we used last year, a total savings of \$104 for the four nights of the reunion.

1. The information that you provide on this form is critical for a successful reunion. All name and base information will be placed on your reunion identification badge. Guests will also receive reunion identification. The reunion ID will serve as your identification throughout the reunion and must be worn, especially while we are in all military or government facilities.

2. <u>PLEASE PRINT</u> or type all information <u>clearly</u>. Do not use abbreviations on any portion of the registration form.

3. <u>RVN OR THAI BASE INFORMATION</u>: Please list only those bases where you served in Vietnam or Thailand. When listing bases, <u>do not abbreviate</u>. When listing squadrons, please indicate Air Police, Security Police, or specific detachments. The information will be used on your reunion ID.

4. <u>HOME ADDRESS and MAILING ADDRESS</u>: This is where we will mail your confirmation.

5. <u>Barksdale AFB ENTRY ACCESS FORM</u>: Please make sure we have your full name as it appears on your ID card (military ID or Driver's License) for yourself and all guests. This information is MANDATORY for access to Barksdale AFB. YOU WILL NOT BE ALLOWED ON BASE IF YOU DO NOT PROVIDE THIS INFORMATION.

6. <u>TELEPHONE AND EMAIL ADDRESS</u>: Your contact information is vital to a successful reunion. You will also receive a copy of this roster upon arrival at the hotel.

7. <u>NAMES OF YOUR GUESTS</u>: Please provide the first name, middle initial and last name of your guest(s) on the Registration Form as it appears on their ID (military ID or Driver's License) they will be using to get on Barksdale AFB as this information will be our VSPA Entry Access List.

8. <u>RENEWAL OF ANNUAL DUES</u>: VSPA <u>members only</u> - you can renew your dues at the time of registration if they are not current. VSPA membership must be current in order to attend the reunion or bring a guest.

9. <u>VSPA MEMBERSHIP</u>: If you are not a member of the Vietnam Security Police Association, please do not send \$15 with this registration form. 2. I will inform my visitors that they must have current proof of insurance, proof of registration and a current/valid driver's license. Additionally, they were briefed that while on this installation all personnel and the property under their control is subject to search.

Disclosure of information is voluntary, however; this information is necessary for validation of identity and may result in a non-issuance determination by the issuing authority.

#### AUTHORITY: 10 U.S.C. 8012, 44 U.S.C. 3101.

**PRINCIPLE PURPOSE**: The date of birth is used for further identification of the individual and for retrieving information from files. Routine use could include disclosure to other investigatory authorities. **DISCLOSURE IS VOLUNTARY**: Failure to provide the information to include date of birth <u>will result</u> in an individual being unable to gain entry onto BARKSDALE AFB.

Five Life Members of the VSPA gathered to wash The Wall on August 30, 2014. Led by Gary Jones, Willie Squires and Jim Stastny, who have been washing The Wall since 2006, they were joined by Ray Silhavy and Steve Gattis. The effort is really an honor and a commitment from the heart. Gary drives from South Carolina, Jim from Maryland and Willie from Virginia. Ray and Steve flew in from Texas along with their wives.

The opportunity to wash The Wall is scheduled by the National Park Service and allows our members to preserve the memory of our brothers who did not survive the war in Vietnam and Thailand. While the Eagle Chapter, AF Security Forces Association, was in charge of the washing effort for Saturday August 30th and again this coming Saturday, September 27<sup>th</sup>, the VSPA led the way with a prayer by Chaplain Jim Stastny and a briefing by Gary Jones that included the history of the washing, as well as the procedures that had to be followed in order to avoid damage. Yes, granite can be damaged.

Lee Chambers is Chairman of the AFSFA Eagle Chapter. The Action Officer for the wash is Steve "Hutch" Hutchison, also of the Eagle Chapter. # WASHING THE WALL CONTINUED.....

We met at 0615 hours at the Flag pole, by the three soldiers statue. FREE on-street parking was available on Henry Bacon Drive and Constitution Avenue (on the side of the street facing the Capitol). The Wall was an easy, short walk from parking. We wore comfortable clothes, including Vietnam Vet hats and jackets. Some wore a light jacket or sweatshirt because it was a bit cool in the early morning. Shoes are always required...no flip-flops because the granite walkway can become very slippery with soap and water! We started washing about 0630 and had to be finished by 0800, when the Memorial officially opened for visitors.

Friends and family were welcome, but no pets. Cameras were a requirement as we washed both The Wall and the granite walkway. Prior to our arrival, Gary advised us that the first washing could be a very emotional experience. We had been there before but never for a washing. We thought we were prepared. . .until about 50 Navy Chief Petty Officers approached in formation and walked through, thanking each one of us, shaking our hands and saying, "Welcome home." There is no way to prepare for that kind of emotion. If you ever have a chance to go to The Wall for the washing, do it. Watch the sun come up and let the whole experience fill your heart. Then stay and enjoy the sense of calm in the early morning before the crowds arrive.



# VSPA SCHOLARSHIP FUND

The VSPA (USAF) has established a scholarship fund in memory of J.J. "Jacob"

Chestnut. J.J. was a career USAF Security Policeman and served two tours in the Republic of Vietnam, with the 12th Combat Security Police and the 633d Combat Security Police. After completion of his military career J.J. Chestnut became a member of the U. S. Capital Police. In 1998, during an attack which shocked the nation, J.J. Chestnut was killed in the line of duty defending the U.S. Capital Building by a deranged individual attempting to gain access to sensitive areas. J.J. Chestnut is buried in Arlington National Cemetery.

All VSPA members, spouses, children, grandchildren, stepchildren/step-grandchildren, and greatgrandchildren are eligible to compete for this scholarship. Normally one \$1,000.00 award is given annually. The award will be granted to those seeking education beyond the high school level and may include trade schools, community colleges, junior colleges or four year college or university and graduate degrees.

The deadline for submission of scholarship applications is the first day of October each year. The basis for the award will be recommendation(s), Grade Point Average (GPA) and the applicant's response to one of the below listed questions. VSPA members may request applications on behalf of applicants via the public bulletin board on the VSPA Web Site, email, or telephone. Applications may also be requested by survivors of a deceased VSPA Member.

# THE SECURITY FORCES MUSEUM LACKLAND AFB, JOINT BASE SAN ANTONIO

The Security Forces Museum lowered all flags during a closing ceremony on August 15, 2014. The ceremony was attended by over 300 Security Forces Defenders, as well as past Air Policemen and Security Policemen who are members of the Vietnam Security Police Association and the Air Force Security Forces Association. Although the Museum closed, the following is an update and overview based upon the result of a combined response from thousands of former Air Policemen, Security Policemen and Security Forces Defenders who reacted with strength, resilience and determination to the news that the Security Forces Museum was closing.

UPDATE: from Ken Neal, VSPA Liaison to the Security Forces Museum and Security Forces Museum Foundation: SEPTEMBER 12, 2014: "Today, the Apprentice Security Forces Class was in the Museum. We also had about six non-Security Forces personnel walk in as guests while the Integrated Base Defense Command, Control, and Communications class (IBDC3) was in the Museum with about 20 class members ranking from TSgt. and up to Major."

The above update from Ken Neal is proof that the uproar created by the combined efforts of the VSPA, AFSFA, Security Forces leadership both past and present, a Facebook "Save the Security Forces Museum" page with 6,110 members, as well as members of Congress and local representatives in Texas, caused the Security Forces Museum to remain open as an integral part of the Security Forces curriculum as well as other events by appointment, even though the funding for the curator was cut from the budget.

CONGRATULATIONS! Our mass email system worked. YOUR effort to write letters and contact members of Congress, as well as the local news media, was very effective and resulted in a major change from the initial decision by the Air Education and Training Command (AETC) to completely close the Museum pending consolidation with another base museum into the Enlisted Heritage and Character Development Center, a new \$50 million complex. #### **OVERVIEW**

VSPA mass email communications are very important. To reproduce them here would take over 16 pages of this issue of Guardmount. Chronologically, we sent emergency email messages to all current members when the announcement was made regarding the closure of the Security Forces Museum. The following is a list of the mass email messages sent by Don Poss from our VSPA web site database:

**FROM VSPA PRESIDENT PETE PIAZZA ON AUGUST 14, 2014:** Talking points prepared by Gary Jones, Jerry Nelson, Steve Gattis and Don Poss for use when writing to members of Congress.

**FROM VSPA PRESIDENT PETE PIAZZA ON AUGUST 19, 2014:** A position paper regarding our collective response to the closure of the Security Forces Museum with the main point that we must be professional in our conduct and communication. We must remember that our Security Forces leadership and the museum foundation had nothing to do with this closure and that we must not attack our people or our curator who lost her job with the closure of the Security Forces Museum. She did an outstanding job for us. Your Security Forces Commanders have fought for years to keep the museum open. We must support them as they continue the fight to preserve our history. That support does not include personal attacks and negative comments that embarrass the VSPA on Facebook or on our Bulletin Board. Do not give away our honor by attacking those who stand with us. We must live by our motto and take care of our own. I have faith in all of you and will always remember that the toughest fighters in the Air Force fight on the ground WITH HONOR.

#### AN EMAIL MESSAGE ON AUGUST 20, 2014 FROM VSPA AFFILIATE MEMBER MG MARY KAY HERTOG WHOSE FATHER, DON REEVES, WAS ONE OF OUR LIFE MEMBERS:

"I have received many emails from people about the Museum closure, along with the AF SF Association emails, and I wanted to make a few comments. I'm sorry to hear SF was given zero prior notice about this decision --that was a foul. But I have to tell you this has been coming for years. I, with the help of others, intervened several times to stave off the closure as far back as 12 years ago. I believe it was Pat Bowden who came up with the great idea to change the SF Basic Apprentice course to have our new Airmen in training spend an hour in the Museum to learn about their heritage. This brought up our visitor numbers in a huge way and justified keeping the Museum open. Lackland is the only installation in the AF that supports two museums, and if one had to close, it will usually be the one with the least amount of visitors.

When I was the Director of Security Forces I was contacted about AETC not being able to keep both museums open because they couldn't afford the salaries of two curators. I made the offer to AETC to pay our curator's salary out of SF funds. They agreed to that and that has kept the museum open for a few more years.

In my group and wing commander positions at Lackland and as the Top Cop and 2AF/CC, I was able to keep tabs on the museum and its status.

But it's a very different and difficult time now and the AF, as well as the other Services, are in dire fiscal straits due to sequestration and other issues. The AF is taking drastic measures to save money and continue its missions. Much of the cuts are coming from big personnel reductions such as selective early retirements--(4 SF colonels this year have to leave early), reduced accessions in basic training; changing high year of tenure rules to get more people out; requiring majors and lieutenant colonels in certain year groups to meet retention boards, and oh by the way, if an officer successfully makes it past a board this year it doesn't guarantee they are exempt from future boards). And there is so much more the AF is trying to do to save money and gain efficiencies, all painful to someone.

So I would ask everyone to think about the people losses versus the buildings that we are going to lose. We may not have our original museum building anymore, but we will never lose our identity as a career field. Our proud heritage and current performance of our outstanding cops around the world will never allow that to happen. But we are part of the AF and therefore we are going to be subject to sacrifices, too.

I understand we will have displays in other locations. I've heard it's the Base Library and I've also heard it may go into the new Enlisted Heritage and Character Development Center. If it's the EHCDC that's great news because thousands of people (parents and our graduated Airmen) will pass through that building every Thursday and Friday during the weekly BMT grad ceremonies and that will expose a huge number of people to SF.

There have been some very negative and downright nasty posts on Facebook from people who don't have the full story of what the AF is having to do just to accomplish our mission. Frankly I'm disappointed by that kind of unprofessional reaction. This is not a personal attack against the SF career field and I hope you can help me spread the word on the very tough fiscal environment the Services are operating in and why these decisions are being made. And the fiscal picture isn't getting any better. There will be even greater changes coming to the career field in the near future which will cause great concern too, but there's no doubt in my mind SF will make the necessary transition and continue to excel in the tremendous missions we do around the world.

We asked General Hertog to clarify a couple of points about the current facility and Museum funds. In the interest of brevity, we have paraphrased both the questions and her comments. Nothing has been deleted that changes the context of the questions or General Hertog's responses.

# Q: What will happen with the current facility? Will it be used for Academy Classrooms, where some exhibits may be displayed?

A: These are all very valid questions about the building's final status and I'm going to contact the AETC and ask why there was no notification to SF that this was coming up fast.

# Q: What will happen with the funds maintained by the SF Museum Foundation? Can they be used to construct world-class displays in the temporary facility?

A: As for the funds in the Museum Foundation, that is not controlled by the wing or AETC from what I remember. I believe that totally falls under the control and management of the SF Museum Foundation. I know as a wing commander at Lackland, I never had access to those funds.

Q: Do we have your permission to share your comments with the VSPA, Safeside Association, <sup>18</sup> Thailand Dog Handlers Association and SAC Elite Guard Association and AFSFA members, so they will have a better understanding of the issues involved with the closure of the Museum?

A: Please feel free to resend my email to all of the SF related associations. I am trying to calm things down because now there are petitions being generated on Facebook and the tone is getting worse because folks just don't know what's going on behind the decision (because no one shared it with the most affected group)! You are so right in saying that if the right people had been notified, up front, alternatives could have been discussed and the command could have had SF support vice recriminations.

#### SUMMARY

The Security Forces Museum remains open for the Defenders attending all phases of the Security Forces Academy. It will also be available by appointment due to the overwhelming response from our members and people like Mary Kay Hertog and BG Coleman. Thanks to Ken Neal, we have a photographic record of every single display and diorama in the Museum. Yes, the Museum will be moving to a much larger temporary facility in the Base Library which has a lot more bathrooms, pending the construction of a new facility. For now, rest assured that our heritage will continue to be taught to Security Forces Defenders and the facility has not permanently closed pending the move. A full inventory has also been completed.

Nemo's War Dog Heroes Memorial, although adjacent to the Museum, is NOT a part of the Museum. All activity regarding Nemo's War Dog Heroes Memorial has been and will continue to be managed by the Nemo's War Dog Heroes Memorial Committee. VSPA Life Members Bill Cummings, Kelly Bateman and Ernie Childers form the nucleus of that committee.

# 2014 ELECTION OF VSPA OFFICERS CANDIDATE BIOS AND BALLOT

VSPA members who attended our 2007 reunion in Washington D.C. voted to modify our by-laws and the election process so that the election would no longer be conducted only at the reunion business meeting. A committee was appointed to determine whether electronic voting could take place via our web site and to develop a process. The committee included Don Poss, Newell Swartz, Sam Lewis and Don Hamilton.

Don Poss thoroughly investigated electronic voting via the Internet and found that it <u>could not</u> be done in an efficient, cost effective manner. He looked at the process as both our Web Master and as a VSPA member who fully supported the idea of voting on-line. Other organizations that had attempted the process had numerous problems that far exceeded our ability to resolve, including multiple votes from different computers and the inability to accurately identify voters who emailed ballots. We simply do not have the manpower to search our records to verify current membership based upon multiple email addresses that have changed without notice to the VSPA, which is something we experience on a daily basis. Multiple votes on-line are a reality, not because people are dishonest, but because computers can be very confusing for some people who might worry that their ballot has not been received and they send it again, or they send it from another computer which could make them appear to be a different person. The only other alternative is to have a mail-in ballot that you can print from our web site, or receive in Guardmount, print and then return.

You can vote at the reunion. If you are not attending, and are reading this on-line, you must be a current member in order to vote and read the bios of those who have declared their intention to run for office. Therefore, the bios, photos and the ballot form have been posted in the Restricted Area of our web site. To vote by mail, you must print the ballot from the web site or from Guardmount and mail it to VSPA Sergeant-at-Arms, Keith Young, WITH A POSTMARK NO LATER THAN SEPTEMBER 29, 2014. Keith will not be running for office, whereas many of the other officers are running for office again. Your membership status will be verified to make certain that only one vote is submitted. All votes will be counted and verified by an election committee at the reunion.

There are SIX positions up for election this year: President, Vice President, 2<sup>nd</sup> Vice President, Secretary, Treasurer and Historian. 
## For Historian: Steve Shelt Life Member #157, Pleiku 67-68

In 1989 I was recruited by the U.S. Department of Energy, Savannah River Operations Office (DOE-SR). During my tenure at the DOE-SR, I was assigned as a Team Leader, Branch Chief, Program Manager, and Division Director. I managed and directed a wide range of programs to include: Physical Security, Protective Force Operations, Intelligence/Counter-intelligence, Fire Protection, Aviation, and Emergency Management. I also directed the security mission for nuclear spent fuel being transported via ocean vessels from foreign country reactors to the U.S. as part of the Nuclear Nonproliferation Treaty. After 9/11, I was assigned a collateral duty to the FBI's Southeast Joint Terrorism Task Force, CSRA Joint Agency and Midlands Weapons of Mass Destruction Working Groups representing DOE Savannah River Operations Office.

I retired from federal service in 2007 and became a consultant to both private industry and the federal government on nuclear and petroleum security, terrorism, emergency services, and aviation safety and management. I completely retired from the work force in 2012. Post retirement I have worked with the Augusta Historical Society working on the National Veterans History Project collecting (videotaping) personal accounts of American war veterans for a better understanding of the realities of war. Those accounts are sent to the National Achieves so that future generations may hear directly from the veterans. I am a member of the county Community Emergency Response Team and a volunteer at the Charlie Norwood Veterans Medical Center, Augusta, GA. I have also provided lectures to the current Air Force Security Forces on the emergence and tribulations of Air Base Defense in the Vietnam War. My favorite activity is hiking and backpacking in the mountains. I am active with veterans organizations such as the American Legion, Post 192, Vietnam Veterans of America, Vietnam Security Police Association (Life Member #157), and the Pleiku Air Base Association.



I have posted previously on this subject but some readers may have missed it. It was also publicized in the Summer 2013 issue of Guardmount. My thanks to the VSPA for supporting me in offering this service. I have shipped eight laptops to VSPA members.



The local computer recycling program sponsored and run by our local Kiwanis chapter and funded by the State of Washington gives me access to a large volume of recycled gear from which I select and restore computers that I then give back to various community groups. I have also made computers available to Vietnam Security Police Veterans whose budgets make it difficult to just go out and buy one. Each computer is fully restored to better than new condition, set up with every type of software a user is likely to need, and is ready to connect to the Internet. I can ship the computer already equipped with a remote viewing program making possible for me to provide tutoring or service when needed.

I set no restrictions to take advantage of this offer for a free computer and in nearly all cases I even cover shipping. If you can't afford a computer just contact me and I will ship you one. I spend many hours making sure every little thing is as perfect as I can make it and I am happy to give my time to make this service possible. If you can afford to you can send me a check for \$25 after you receive the computer to cover most of my out of pocket shipping expense but that is not a requirement. It is most important to me to know that no one of our Brothers is disconnected from the Internet. I prefer to limit the service to Vietnam/Thailand Security Police Vets but I will entertain requests for computers for other Veterans.

Many computer users are unaware of how to keep their computers running smoothly. I have assisted hundreds of folks and it is clear that many have little idea how to really enjoy computers. It is great fun to show these folks how to overcome these common problems. I spent 25 years teaching the sports of hang gliding and paragliding. You might not think so but there are amazing parallels to teaching people to jump off cliffs and teaching people to use computers; they both look like scary and complicated things to do but I am a specialist in teaching scary, complicated things! I am a very patient guide and have had great success in tutoring computer users and servicing computers both in person and by means of the remote viewing programs and telephone. The majority of my clients are seniors, even older than we Vietnam Veterans!
